- 3. The learned counsel for the applicant submitted that the cause of action did not arise for applicant to file present O.A. on 10.6.2023 as has been noted in the objection. The learned counsel submitted that only after the candidate Dr. Smt.

Manisha Dighore did not resume the duty, though she was given appointment on the subject post, cause of action arose for claiming the said post by the applicant. Considering the dates, which are stated by the applicant and which are revealing from the documents also, it does not appear to me that the application has been filed by the applicant beyond the period of limitation. The objection as about limitation therefore does not sustain. Insofar as objection regarding adding the candidates, who are above in general merit list, it can be stated that 2 candidates, who are above in the merit are declared non-eligible for claiming the post. The said documents are also brought to my notice. It does not therefore appear to me that said objection can be sustained at this stage. In the circumstances, both the objections are overruled.
