He has submitted that during pendency of the present O.A., the Collector, Ahmednagar received ACRs.

of the applicant for the year 2001 to 2003. Therefore, it is just and proper to direct the respondents to consider the case of the applicant afresh, as the decision in respect of applicant's promotion was deferred in the D.P.C. meeting held on 18.04.2006. In view of the above, the respondents may be directed to consider the case of the applicant in the forthcoming D.P.C. meeting and therefore, he prayed to dispose of the present Original Application.

3. Learned Presenting Officer has submitted that necessary orders may be passed.

4. On perusals of the record, it reveals that the case of the applicant for promotion in the cadre of Awwal Karkoon has been placed before the D.P.C., which was held on 18.04.2006 and on perusal of the said minutes of D.P.C. meeting dated 18.04.2006, it reveals that the applicant was held eligible for promotion, but as the ACRs of the applicant were not available, the directions were given to call for it. No decision regarding grant or rejecting the promotion to the applicant

has been taken by the D.P.C. and therefore, the applicant approached this Tribunal by filing the present Original Application. During pendency of the present O.A., the Collector, Ahmednagar had received ACRs of the applicant for the year 2001 to 2003. Now the relevant documents are available with the respondents and therefore, it is just and proper to direct the respondent No. 1 i.e. the Collector, Ahmednagar to place the case of the applicant before D.P.C. afresh along with ACRs for the year 2001 to 2003 and to take appropriate decision as per the rules.

5. Therefore, the respondent No. 1 i.e. the Collector, Ahmednagar is directed to convene D.P.C. meeting and to consider the applicant's case afresh within a period of three months from the date of this order and to take appropriate decision as per the rules. The decision of the D.P.C. shall be communicated to the applicant in writing.
