5. The O.A. No.1267/2023 is therefore disposed off. 'No Order as to Costs'.

	Officer (GP), Zilla Parishad, Kolhapur' to post of 'Deputy Chief Executive Officer, Zilla Parishad, Ahmednagar'. However, in the meanwhile some compliant was received by office of 'Additional Chief	
	Secretary' and 'Chief Electoral Officer, Maharashtra State' from local organization by name 'Garjana Sangathna, Kolhapur' on 12.01.2024 which then came to be forwarded to 'Rural Development Department'.	
	3. Learned P.O. thereupon states that in meeting of 'C.S.B.' of 'Rural Development Department' held on 16.02.2024 this compliant against Applicant came to be considered and accordingly it was decided that Applicant be transferred to post of 'B.D.O., Panchayat Samiti, Pusad, District Yavatmal' by revoking earlier	
	recommendation to transfer Applicant to post of 'Deputy Chief Executive Officer, Zilla Parishad, Ahmednagar'.	
	4. Learned Advocate for Applicant stresses on the point that in subsequent meeting of 'C.S.B.' of 'Rural Development Department' held on 16.02.2024 no cognizance was taken of letter submitted by 'District Collector & District Election Officer Kolhapur' dated [ <i>P.T.O.</i> 07.02.2024 to 'Deputy Secretary, Rural Development

Department' exempting Applicant from all work related to 'General Election to Lok Sabha 2024'. He further emphasizes on the point that 'District Collector and District Election Officer, Kolhapur' letter dated 07.02.2024 should have been considered in its entirety in meeting of 'C.S.B.' of 'Rural Development Department' held on 16.02.2024.

5. Learned Advocate for Applicant also mentions that two other officers who are also working on equivalent senior posts of (i) 'Deputy Chief Executive Officer (G.A.D.), Zilla Parishad, Kolhapur' and (ii) 'Project Director (Jal Jeevan Mission) & 'Deputy Chief Executive Officer, Zilla Parishad, Kolhapur' were exempted because of letter of 'District Collector and District Election Officer, Kolhapur' dated 07.02.2024. The two officers are thus not transferred by 'Rural Development Department' as their transfers were not recommended in meeting of 'C.S.B.' of 'Rural Development Department' held on 16.02.2024.

The Applicant has been transferred from the 6. post of 'Deputy Chief Executive Officer (GP), Zilla Parishad, Kolhapur' to post of 'B.D.O., Panchayat Samiti, Pusad, District Yavatmal' as per recommendation of 'C.S.B.' of 'Rural Development Department' held on 16.02.2024. The Applicant had not been assigned any election related duty by 'District Collectorand District Election Officer, Kolhapur' letter dated 07.02.2024. However, 'File Noting' indicates Applicant had been initially proposed by 'C.S.B.' to be transferred on 06.02.2024 on ground that he had been assigned work relating to 'General Election of Lok Sabha 2024'. However, in the subsequent meeting of 'C.S.B.' of 'Rural Development Department' held on 16.02.2024 although the two officers on equivalent senior posts were not transferred in consideration of 'District Collector and District Election Officer, Kolhapur' letter dated 07.02.2024; & though name of Applicant was also included in it; yet Applicant was transferred only because there was compliant of 'Garjana Sangathna, Kolhapur' which had been forwarded by office of 'Additional Chief Secretary' & 'Chief Electoral Officer, 12.02.2024 to 'Rural Maharashtra State' on Hence, the transfer of Development Department'. Applicant is not really on grounds of any work assigned to him in relation to 'General Election Lok Sabha 2024'; but only due to ambiguous compliant about

apprehension of role Applicant may play during 'General Election of Lok Sabha 2024'.

7. The compliant about Applicant made by 'Garjana Sangathna, Kolhapur' was thus required to be examined by 'Rural Development Department' to decide as to whether it was to be acted upon or if it was to be considered as 'Anonymous Compliant' as per 'G.A.D.' G.R. dated 26.02.2015. However, considering the fact that no other officer has been posted in place of Applicant on post of 'Deputy Chief Executive Officer (GP), Zilla Parishad, Kolhapur' the 'Balance of Convenience' at this stage lies in favour of Applicant. The Applicant is therefore permitted by way of 'Interim Relief' to continue to work on post of 'Deputy Chief Executive Officer, Zilla Parishad, Kolhapur'.

8. The office objections, if any, are to be removed and court fees to be paid, if not already paid.

9. Issue notice before admission returnable on 12.03.2024.

10. Applicant is authorized and directed to serve on Respondent intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Private service is allowed. Respondents are put to notice that the case may be taken up for final disposal at the stage of admission hearing.

11. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

12. By Hand delivery, speed post, courier notice to be served and acknowledgement be obtained and produced along with affidavit of compliance in the Registry within one week. Applicant is directed to file Affidavit of compliance and notice.

13. In case notice is not collected within <u>seven</u> days or service report on affidavit is not filed <u>three</u> days before returnable date, the Original / Miscellaneous Applications shall be placed on board before the concerned Benches under the caption "<u>for Dismissal</u>" and thereafter on the subsequent date the Original / Miscellaneous Applications shall stand dismissed.

serving on posts of 'B.D.Os.' and 'Assistant B.D.Os' in 'Kolhapur District' have been allowed to continue on their present posts even after completing '3' Years out of '4' Years would thus suffer from vice of arbitrariness in decision making by 'Competent Transferring Authority' and next 'Superior Transferring Authority' under 'Section 4(4)(i)' and 'Section 4(5)' of Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005'. Therefore 'Rural Development Department' to reexamine and file 'Affidavit-in-Reply' as to why other officers if any who are serving on posts of 'B.D.Os.' and 'Assistant B.D.Os' in 'Kolhapur District' have been allowed to continue on their present posts inspite of the fact that they came under purview of directions in 'Election Commission of India' letter dated 21.12.2023.

6. The Applicant is therefore permitted to continue to work on post of 'B.D.O., Panchayat Samiti, Hatkanangale, District Kolhapur'. Therefore, the officer serving on the post of 'B.D.O., Panchayat Samiti, Khatav, District Satara' at Sr. No.11 as well as officer serving on the post of 'B.D.O., Panchayat Samiti, Talasari, District Palghar' at Sr. No.04 who was to replace the officer at Sr. No.11 as 'B.D.O., Panchayat Samiti, Khatav, District Satara' are consequently also allowed continue on their respective posts till 'Additional Information' as directed is submitted by 'Rural Development Department'.

7. The 'Rural Development Department' would this be at liberty to re-examine if there has been any discrimination in transferring the Applicant from post of 'B.D.O., Panchayat Samiti, Hatkanangale, District Kolhapur' to post of 'B.D.O., Panchayat Samiti, Khandala, District Satara'; so that thereupon grant of 'Interim Relief' can be reviewed in respect of the Applicant and other Officers at Sr. No.4 & Sr. No.11 of 'Transfer Order' dated 23.02.2024 of 'Rural Development Department'.

8. The office objections, if any, are to be removed and court fees to be paid, if not already paid.

9. Issue notice before admission returnable on 12.03.2024.
