3. Admittedly, the applicant has been removed from the service by the order dated 16.07.2020 (Annexure A-2) issued by the Additional Director General of Police and Inspector General of Prisons and Correctional Service, Maharashtra State, Pune. Against the said order of removal, the applicant preferred departmental appeal by way of appeal memo dated 18.08.2020 (Annexure A-3) before the authority of Director General of Police, Prisons and Correctional Service, Maharashtra State, Byculla, Nagpada, Mumbai.

4. During pendency of this O.A., it transpires that the authority of Director General of Police, Prisons and Correctional Service, Maharashtra State, Byculla, Nagpada, Mumbai, before whom departmental appeal was preferred is abolished as per G.R. dated 26.02.2021 issued by the respondent No. 1, which is produced by the respondents along with their affidavit in reply at page No. 109 of the Paper Book.

5. Meanwhile, the authority, which imposed the punishment by impugned order dated 12.02.2021 (Annexure A-6) communicated to the applicant that the departmental appeal may be preferred before the State Government, who is the next higher authority of the disciplinary authority. The applicant has challenged this order dated 12.02.2021 in this O.A., which is signed by the respondent No. 2 on behalf of disciplinary authority i.e. the Additional Director General of Police and Inspector General of Prisons and Correctional Service, Maharashtra State, Pune. In fact, as per this order, the disciplinary authority has rightly pointed out the proper appellate authority for deciding the departmental appeal, before whom the applicant could have presented the departmental appeal.

6. In the facts and circumstances as above, the provisions of Rule 21 of the Maharashtra Civil Services (Discipline and Appeal) Rule, 1979 are also be relevant, which are as follows :-

“21. Submission of appeals.- (1) Every appeal shall be submitted to the authority which made the order appealed against: Provided that:

(a) where such authority is not the Head of the Office in which the appellant may be serving, or

(b) where the appellant has ceased to be in service and such authority was not the Head of the Office in which the appellant was serving immediately before he ceased to be in Service, or
