- 1. Heard Shri A. V. Bandiwadekar, the learned Advocate for the Applicant, Ms S.P. Manchekar, the learned Chief Presenting Officer for the Respondent Nos.1 & 3 and Ms Seema Saroj holding for Shri D. B. Khaire, learned Advocate for the Respondent No.2.
- 2. Learned Advocate for the Applicant draws attention to the Affidavit-in-Reply filed by the Respondent No.3 (page 421, para (3.1)) stating that the said Act (as amended) does not empower PEB at the Commissionerate level to effect the internal transfers. He, further draws attention to the observations by the Respondent No.3 that the matter would be examined to see if suitable Government order / legislative amendment to be effected to settle the matter. Affidavit-in-Reply filed by the Respondent No.3, however mentioned that this is a posting order and not transfer order by the Commissioner.
- 3. According to the learned Advocate for the Applicant there is no difference in 'transfer' and 'posting'. He says that the internal positing is also covered

under the same. He further states that an order issued by the Home Department dated on 08.06.2018 (Marked as 'X' for identification) in which the officers at Sr. Nos.06, 81, 82, 92 and 95 have been given internal posting in the Unit directly by the State Government. He, therefore, contends that now the Government has taken upon itself to do internal transfers.

- 4. On query regarding large number of those in the same order which do not mention internal posting, learned Advocate for the Applicant points out that all these orders which do not provide internal posting are illegal. Learned Advocate in Para No.10 refers to the decision by the Hon'ble Tribunal in O.A.668/2017 (Ujwala Santosh Ghavte V/s. State of Maharashtra & Anr.), dated 17.01.2018, in which it was decided that shifting an employee from one place to other in same town amounts to transfer.
- 5. Learned Advocate for the Applicant confirms that the Applicant has been transferred from Navi Mumbai to Mumbai on 20.06.2018. He insists that even then petition has not become infructuous and legality of the same needs to be decided. In support of this, learned Advocate cites judgment of the Hon'ble Bombay High Court in 2003 (4) Mh. L. J. 423 (Prabhakar S. Jagdale V/s. Kalyan Dombivali Municipal Corporation). The facts of the case cited by the learned Advocate do not appear to be in confirmation to the point contended by him. Learned Advocate, further, states that he is not in a position to cite any judgment regarding 'transfer' to support his arguments.
- 6. Learned Advocate for the Applicant further refers to O.A.No.284/2017 (Dr. Madhav A. Waghmare V/s. State of Maharashtra) dated 24.07.2017 of this Tribunal which considers that retirement will not cause any difficulty in examining the order of suspension when he was in service. The facts in this case are, however, different. He, however, argues that the Petitioner will lose his status, though there is no other loss by transfer.
