- 2. Applicant, Medical Officer seeks implementation of order dated 13.07.2016, 05.10.2016 and 13.10.2016. The Government was directed to consider the vacancies which are falling on 1st September of every year as the date of eligibility and consider the applicant for the promotion to the post of D.H.O.
- 3. Learned Counsel has submitted that in the year 2014-15 there were 37 vacancies, out of which the Respondents filled only 20 vacancies. Learned Counsel has submitted that the Applicant was denied promotion for one more reason i.e. the Applicant holds Diploma in Public Health from Kerala University and the State of Maharashtra does not recognize the same. The Applicant therefore filed O.A.No.849/2018 which was decided by order dated 04.02.2022 by M.A.T. Bench Aurangabad wherein the Tribunal considered the post graduate diploma in Public Health (D.P.H.) from the Sree Chitra University as adequate qualification for conferment of promotion as District Health Officer in terms of Maharashtra Medical and Health Services, Class-I, Recruitment Rules, 1981.
- 4. Learned Counsel has further submitted that when the D.P.C. meeting was conducted on 28.12.2020, the Department did not consider the year-wise vacancy from 1st September and Respondents clubbed all the vacancies from 2012 to 2018. He has further submitted that in the D.P.C. meeting held in 2018 and 2020 all the 17 reserved posts were kept aside and only 20 posts were filled up by the Department. At the time of D.P.C. meeting dated 11.04.2018 and 13.04.2018, the Applicant was placed at Sr. No.1383 for 37 posts.

Tribunal's orders

- Learned C.P.O. has informed the Tribunal in short that the applicant did not fall in the consideration zone and never reached to that seniority, to be given promotion to the post of D.H.O. Learned C.P.O. has relied on the Additional Affidavit dated 23.11.2023 filed on behalf of Respondent through Ms. Karuna B. Surwade, Chief Officer, Administrative in the office of Commissionerate of Health Services, Mumbai. She pointed out Annexure R-5 of the said affidavit, the chart furnished by the Respondent giving details of dates of the D.P.C. meeting and promotions given.
- It is mentioned in the said Chart that in the D.P.C. meeting held in the year 2019-20 the first eligible candidate was at Sr. No.108 of the seniority list for the period from 1996 to 2008 and the last candidate was at Sr. No.549 in the seniority list published in the year 2009. Applicant's seniority in the year 2009 is at Serial No.627 which puts him out of the zone of consideration. In the year 2021 the Rules were changed by Notification dated 18.01.2021 wherein amendment was made for promotion to the post of D.H.O. IN the said G.R. 25% quota weightage was given to M.B.B.S and Diploma persons. In the D.P.C. meeting held on 18.04.2022 the first candidate was at Sr. No.151 and last candidate was at Sr. No.894, the Applicant was at Sr. No.3430. It is seen that again the Applicant was out of the zone of consideration. In the D.P.C. meeting held on 25.08.2023 the first candidate was at Sr. No.1079 and last candidate was at Sr. No.1273, the Applicant was at Sr. No.2638. It is seen that again the Applicant was out of the zone of consideration.
- 7. At the request of learned Counsel adjourned to 02.07.2024.
