Learned Counsel has submitted that by order dated 30.10.2019 Applicant was transferred as Treasury, Awal Karkoon at Tahasil Office, Murbad, District Thane which is a difficult area. Learned Counsel has submitted that on 30.05.2024 Applicant has given 10 options for the transfer. Learned Counsel has submitted that none of the options given by him were considered. He states that by order dated 14.08.2024 various transfers were made wherein all the 10 options/preferential post submitted by the Applicant except one post at Serial No.8, as Circle Officer, Thakurli, Tahasil Office, Kalyan is vacant till date.
- 4. Learned Counsel has further submitted that Private Respondent no.2 who was suspended in view of pending ACB case was reinstated. After reinstatement within three months he was transferred on an executive post as Revenue Awal Aarkoon Tahasil Office, Kalyan. Learned Counsel has submitted that as per G.R. dated 14.10.2011 posting a person on an executive post after suspension is not permissible.

- 5. Respondents are directed not to pass any order transferring anybody on the post of Circle Officer, Thakurli, Tahasil Office, Kalyan till next date
- 6. The office objections, if any, are to be removed and court fees to be paid, if not already paid.

- 8. Applicant is authorized and directed to serve on Respondent intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Private service is allowed. Respondents are put to notice that the case may be taken up for final disposal at the stage of admission hearing.
