Chougule, learned Presenting Officer for the Respondents and Shri S. S. Dere, learned Advocate for Respondent.</p> <p>2. Learned Advocate for the Applicant reiterated that the Transfer Order dated 08.09.2023 of Applicant Shri S. S. Supe, Joint Secretary, Food, Civil Supplies and Consumer Protection Department was issued even though the CSB No.3 has specifically mentioned that the Applicant not due for transfer and that the Applicant was also due for retirement on 31.12.2023. The 'CSB No.3' had infact in respect of the Respondent No.3- Shri S. U. Gaikwad, Dy. Secretary, Finance Department clearly recommended that he was not also due for transfer from the post of Deputy Secretary, Finance Department.</p> <p>3. Learned Advocate for the Respondent No.3-Shri S. U. Gaikwad, Deputy Secretary, Finance Department affirmatively stated that there are other several instances where the officers on the post of Joint Secretary / Deputy Secretary have been transferred within 'One Year' from their 'Dates of Retirement'. He specifically cites the case of Applicant himself having been transferred as Joint Secretary, Food, Civil Supplies and Consumer Protection Department by order dated 16.12.2022 on 'Vacant Post' which became</p> |

available only because the incumbent officer who working as Joint Secretary, Food, Civil Supplies and Consumer Protection Department was transferred although he was within One Year from his 'Date of Retirement'. This claim of the learned Advocate of Respondent No.3 – Shri S. U. Gaikwad, Deputy Secretary, Finance Department needs to be ascertained specifically and information in this regard obtained by learned P.O.

4. Learned P.O. has filed Affidavit in Reply on behalf of Respondent Nos.1 and 2. It is taken on record.

5. Learned P.O. is informed with reference to order dated 11.09.2023 wherein it had been mentioned that there may be instances of Joint Secretary/ Deputy Secretary of some other 'Administrative Departments' who have in the recent past been transferred within 'One Year' of their 'Date of Retirement'; their data should be furnished by Respondent No.1 to seek vacation of the 'Interim Relief'. However, learned P.O. informs that the data sought by order dated 11.09.2023 is still awaited from the office of 'Additional Chief Secretary (Services) GAD'. If, indeed Joint Secretaries/ Deputy Secretaries have been transferred in the recent past within 'One Year' from their 'Date of Retirement' when the law under 'Section 5(1)(a)' of Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005; even provides for extension of their tenures after they are due for transfers on grounds that less than 'One Year' of Government Service is left, then it justifiably becomes a matter of deep concern; as such type of 'Mid Term Transfers' would leave many Joint Secretary/Deputy Secretary vulnerable to abrupt transfers from one 'Administrative Department' to another in the very last stages of their Government Service.

Gaikwad, Learned Presenting Officer for the Respondents in course of Final Hearing.</p> <p>2. In the course of Final Hearing, it has been observed that there is large Variance in Numbers of Vacant Posts as on the (i) Date of Meeting of DPC' of Deputy Collectors on 02.03.2023, (ii) Date of Issue of Promotion Orders on 24.04.2023 and (iii) Date of Letter for Preference of Allocation of Revenue Division on 23.05.2023. Further information of 'Vacant Posts' of Deputy Collectors separately obtained under 'The Right to Information Act, 2005' from the offices of (i) Divisional Commissioner, Konkan Division on 11.05.2023 and (ii) Divisional Commissioner, Pune Division on 16.02.2023 shows significantly higher number of 'Vacant Posts' of Deputy Collectors as on the 'Date of Issue of Promotion Order' on 20.04.2023.</p> <p>3. The Learned PO was therefore informed during the course of 'Final Hearing' that these figures of 'Vacant Posts' of Deputy Collectors available on the 'Date of Issue of Promotion Order' on 24.04.2023 will have to be first reconciled because as per GAD GR dated 01.08.2019, the course of action to issue Promotion Orders on 24.03.2023 and then to undertake Allocation of Revenue Divisions by sending letter on 23.05.2023 became divergent, although they had to be co-terminous and intently synergized. This was not observed as is evident because the action of Issue of Promotion Orders was taken separately on 20.04.2023 while the process to make Allocation of Revenue Division commenced subsequently and much later on 23.05.2023. Therefore, it becomes significantly important that the 'Number of Vacant Posts' that were available as on the 'Date of Issue of Promotion Orders' of 20.04.2023 are available for all these Deputy</p> |

Collectors who were found eligible for promotion by DPC.

4. Learned PO thus was informed to reconcile the figures after seeing File Notings. In the course of Final Hearing, it was also observed that another set of officers came to be promoted to the cadre of Deputy Collectors on 29.08.2023 and they have now been informed on 06.09.2023 to give their preferences for Allocation of Revenue Division. In this letter dated 06.09.2023, it is seen that there is 1 Vacant Post in Konkan-1, 5 Vacant Posts in Konkan-2, 2 Vacant Posts in Pune Division and 3 Vacant Posts in Nashik Division.

5. The Ld. PO is therefore informed that the Applicants who were promoted as Deputy Collectors on 20.04.2023 and Deputy Collectors subsequently promoted on 29.08.2023 being from the same 'Select List' cannot be given different choices of posts of Deputy Collectors for Allocation of Revenue Division viz. the 'Number of Vacant Posts' cannot be varied to the advantage of few Deputy Collectors subsequently promoted on 29.08.2023. They have to be available for even the Applicants who were promoted earlier on 20.04.2023. Hence it becomes significantly important that till such time as the correct figures of 'Vacant Posts' of Deputy Collectors as on 20.04.2023 is brought on record by the Respondents and all 'Vacant Posts of Deputy Collectors as of 20.04.2023 are available to Applicants for giving their Preference for Allocation of Revenue Division, above mentioned 'Vacant Posts' now been shown as available for Deputy Collectors promoted on 29.08.2023

i.e. (i) One Vacant Post in Konkan-1, (ii) 5 Vacant Posts in Konkan-2, (iii) 2 Vacant Posts in Pune Division and 3 Vacant Posts in Nashik Division are directed to be kept available also for the Applicants who were promoted earlier as Deputy Collectors on 20.04.2023. These 'Vacant Posts' now shown as available as per letter of 06.09.2023 are not to be filled-up by the Revenue and Forest Department till 'Next Date'.
