Applicant has prayed to condone delay of 4 years, 7 months and 14 days in filing the O.A. challenging the impugned order dated 14-02-2012 by which her application for appointment on compassionate ground has been rejected. It is contention of the applicant that due to death of her husband, she suffered some mental disorder and she was under treatment since April, 2012. Therefore, she could not able to approach the Tribunal to file O.A. and challenge the impugned order in time.

3. It is her further contention that she was also engaged in filing M.A.No.212/2011 before the Civil Court at Ahmednagar for getting Succession Certificate under Indian Succession Act. Due to family problems as well as the financial problems she could not approach the Tribunal and delay is caused for filing O.A. Delay is not intentional and deliberate, and therefore, she prayed to condone the same.

4. Respondents resisted the application on the ground that delay is not properly explained by the applicant and the same is inordinate and abnormal. Therefore, they have prayed to reject the M.A.

5. Learned Advocate for the applicant has submitted that because of the ill-health of the applicant she could not approach the Tribunal to challenge the impugned order in time. He has submitted that applicant is the only adult member in her family and there is no other person to look after her family. She was suffering from mental disorder from 2012 and was under treatment of Dr. NirajKarandikar at Ahmednagar and also Noble Hospital at Pune. After recovery from illness, she has approached the Tribunal and filed O.A. Therefore, some delay is caused in filing the O.A. Learned Advocate for the applicant has submitted that because of the just and sufficient reasons, it is necessary to condone the delay. Therefore, he has prayed to allow the M.A.

6. Learned P.O. for the respondents has strongly objected to condone the delay caused for filing the O.A.

7. On perusal of record, it reveals that husband of the applicant died on 13-02-2011 leaving behind the applicant and 2 children.

Medical certificate issued by Dr. Karandikar shows that the applicant is suffering from mental disorder and she is under his treatment since April, 2012. There is no reason to discard certificate issued by Dr. Karandikar. Documents on record show that due to ill-health of the applicant she could not able to approach Tribunal challenging the impugned order. Reasons and cause shown by the applicant are sufficient to condone the delay caused for filing O.A. As valuable rights of the applicant are involved in the O.A., it is just and proper to condone the delay caused for filing the O.A.

7. Consequently, M.A. is allowed. Delay of 4 years, 7 months and 14 days caused for filing the O.A. is hereby condoned. There shall be no order as to costs.
