2. Since in all these OAs contentions raised and prayers made are identical, I have heard these OAs together.

3. The grievance of the present applicants is that they have been refused the study leave on untenable grounds. It is the contention of the applicants that the reasons, which are assigned for refusing the study leave to them, are unsustainable. It is further submitted that when permission has been granted to the candidates, who are to pursue the course in the Government College, no different criteria could have been applied only on the ground that the present applicants are intending to take

admission in the private college. It is further contended that the reason of Covid Pandemic cannot be now pressed. It is further contended that 30<sup>th</sup> October, 2023 is the last date for taking admission for these applicants in the private college and if the applicants failed in taking admission by the said date the other candidates are likely to be admitted by the said colleges and if it so happens these applicants will lose opportunity to pursue post-graduation course though they are entitled for completing the said course by taking study leave.

4. Learned Chief Presenting Officer opposed the submissions as are made on behalf of these applicants. Learned C.P.O. submitted that study leave can be granted up to 3% of the working strength of the employees. Learned C.P.O. submitted that as per the instructions received to him presently 583 Staff Nurses are working in the Government hospital. 3% of the said number comes to 17 and 17 candidates have already been permitted to complete the said course and study leave is granted to them. In such circumstances, according to him, no study leave can be granted to these applicants and study leave has been rightly declined to these applicants by the competent authority. He, therefore, opposed for granting any interim relief.

5. It is not in dispute that the study leave can be granted to maximum 3% of the total working strength of the employees in the institution. When it is the statement made by the learned C.P.O., on instructions, that to that extent the candidates are already permitted, it does not appear to me that any relief as has been claimed by the applicants can be granted in their favour at this stage. In the circumstances, I deem it appropriate to issue notice to the respondents to file a detailed affidavit in reply. Hence, the following order: -

**ORDER**

(i) Issue notice to respondents, returnable on 24.11.2023. **Learned C.P.O. is directed to submit the list of 17 candidates, who are granted study leave and relieved, on Monday i.e. on 30.10.2023.**

(ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

(iii) Applicants are authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

(iv) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

(v) The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry

before due date. Applicants are directed to file affidavit of compliance and notice.
