2. It is the case of the applicant that in the current annual transfers she has been given posting at the place for which she has not given any option. The learned counsel for the applicant submitted that while filling in the concerned form the applicant has submitted her choices in order of preference considering her seniority in the cadre. The learned counsel submitted that the applicant has submitted the choices and preferences, which are not given by any of the Medical Officers senior to her. It is the further case of the applicant that her husband, who is also working as a Medical Officer, has been transferred at Shelti, Tq. Shahada, which is 80 kms away from the place of posting given to the

applicant. The learned counsel submitted that the applicant has made a representation on 12.6.2023 to the Medical Commissioner and on 13.6.2023 has forwarded a request letter to the District Health Officer, Zilla Parishad, Nandurbar for requesting him not relieve her till her representation is decided. The learned counsel on instructions submitted that even if the representation is not favourably decided, the applicant will not insist for any favourable order and will join at the transferred place. Till then the learned counsel for the applicant has prayed for an order directing the respondents not to relieve the applicant from her existing post.

3. The learned Chief Presenting Officer has opposed for granting any such relief. It is submitted that there is no such ground made out by the applicant for considering her such request. In the circumstances, the prayer is made for rejecting the prayer of interim relief and time is sought for submitting the detailed affidavit in reply.

4. It is not disputed by the respondents that the applicant has not yet been relieved from her existing

post. In view of the submission made by the learned counsel on instructions of the applicant that if her representation is decided by the competent authority against her, she will immediately join at the transferred place according to the impugned order and till then she shall be allowed to work at the existing place, I deem it appropriate to pass the following order :-

ORDER

Issue notice to respondents, returnable on 18.8.2023, **till then or till the representation of the applicant dated 12.6.2023 is decided by the competent authority, whichever is earlier, the respondents shall allow the applicant to work at the existing place.**
