Learned Counsel submitted that the applicant did not commit breach of any condition prescribed by MPSC. Learned Counsel submitted that applicant was not wearing a digital watch and it was a sports watch which can be used only for the purpose of knowing time. Learned Counsel further pointed out that, on the contrary, respondents have not followed any procedure before passing the impugned order and has arbitrarily debarred the applicant from appearing in all future examinations. Learned Counsel in the circumstances has prayed for an interim order thereby directing the respondent no.3 MPSC to accept the application of the present applicant subject to outcome of the present O.A.

notwithstanding the order passed by it on 10-02-2023.

5. Learned CPO has opposed for grant of any interim relief stating that the applicant had indulged in malpractices in the examination and as such no equitable relief can be granted in his favour.

6. I have considered the submissions made on behalf of the applicant as well as the respondents. At this juncture, I may not indulge in making any discussion on merit of the contentions raised in the O.A. In fact, respondents ought to have filed the affidavit in reply promptly whereas the same has not been filed even after availing due opportunities. After the affidavit in reply is filed matter can be heard and decided on merits. However, as has been submitted on behalf of the applicant the next recruitment process for the recruitment of 615 posts of PSIs has already commenced and the last date of making application for the said post is 03-10-2023.

7. In the circumstances, without going into merits of the contentions raised in the O.A., it appears to me that subject to outcome of the present O.A.,

applicant can be permitted to apply for the said post for the reason that last date of making application is 03-10-2023. At this stage, nothing can be said whether the O.A. will be decided in favour of the applicant or against him. However, if the applicant is not at present allowed to apply for the post, even if ultimately the O.A. is allowed, the loss caused to the applicant may not be compensated. As against it, presently, if the applicant is provisionally allowed only to make application for the newly advertised post, and if ultimately, he fails in securing any relief in the present O.A., no prejudice is likely to be caused to the respondents, since he will be disentitled from participating in the further selection process.

8. For the reasons stated above, I am inclined to pass the following order:

2. The applicants are presently working in the cadre of Inspectors of Motor Vehicle. They are presently posted and working in the Nandurbar District, which as claimed by them in this application, is a Tribal District. It is the case of the applicants that they have been working in the Tribal district for the period of about 4 years. According to the applicants, in view of the Government Resolution dated 6.8.2002 they all are entitled for getting their choice posting at the time of their transfer from the existing place and post. It is the further case of the applicants that the respondents have commenced the process for effecting transfers of officers from the cadre of Inspector of Motor Vehicles. It is the grievance of the applicants that the list of the officers due for transfer, which has been published recently does not reflect the information that the present applicants are working in the Tribal district as is shown in respect of the officers working in the Naxalite affected area.

3. Shri Avinash S. Deshmukh, learned counsel appearing for the applicants submitted that the Government Resolution dated 6.8.2002 provides for choice posting for the officers working in Tribal area, as well as, Naxalite Affected Area. Learned counsel further submitted that in view of the aforesaid Circular, at the time of making transfers it is ensured by the Government that the officers who have provided services in Naxalite Affected Area or in Tribal area for more than 2 years are given the posting according to the choices/preferences given by the said officers. Learned counsel submitted that forms which are provided for filling the information online and accordingly the information which has been published by the respondents on 23.9.2023, which become accessible to the applicants on 25.9.2023, in respect of "Inspector, Motor Vehicle Eligible List-2023", which contain names of total 166 officers and also contains the names of the present applicants, do not disclose the fact that the applicants are presently working/have worked in Tribal affected area as has been mentioned in respect of the officers working in the Naxalite Affected Area. Learned counsel submitted that the applicants, therefore, apprehend that despite having worked in Tribal area for about 4 years and though the G.R. dated 6.8.2002 vests right in these officers to seek next posting in the choice of their district they may not

be considered for such choice posting for want of such information in the eligible list of 2023 published by the respondents. In the aforesaid facts and circumstances, the applicants have approached this Tribunal with a prayer seeking direction against the respondents to reflect the information as about the present applicants showing that they had worked in Tribal district as has been shown in the cases of the officers who had worked/working in the Naxalite Affected Area.

4. Learned Chief Presenting Officer submitted that as per the instructions received to him from the officer working in the office of respondent No. 2, much time will be required for issuing orders of transfers and at present the work of collecting information/data only is going on. Learned C.P.O. further submitted that the said officer also informed him that if the officers had worked in Tribal Area they would be definitely given the benefit of the G.R. dated 6.8.2002, if they are otherwise found eligible. Learned C.P.O. further submitted that the officer concerned has also informed him that Civil Services Boar has also not yet been constituted, without which the transfers are not likely to be effected. Learned C.P.O. in the circumstances submitted that the request of the applicants, therefore, has lost the significance and

there appears no need of any order as sought by the applicants, in view of the stand of the Government.

5. Thereupon, Shri Deshmukh, learned counsel appearing for the applicants submitted that if that may be the position as has been clarified by learned C.P.O. there shall not be any impediment for accepting the request of the applicants, so as to ensure that the applicants get the benefit for which they are entitled. Learned counsel submitted that the applicants apprehend that if such information is not made available in writing the applicants may not be considered for the benefits under the concerned G.R.

6. After having considered the submissions as are made on behalf of the applicants and the respondents, it appears to me that the contention of the applicants is principally accepted by the respondents. In the circumstances, so as to remove apprehension in the minds of the applicants there may not be any difficulty in directing the respondents to update the information published on 23.9.2023 by introducing a remark against the names of the applicants to the effect that they had worked/working in the Tribal area as is shown in respect of the officers working in the Naxalite Affected Area.

7. In view of the fact that, aforesaid is the only relief sought in the present O.A., the O.A. is disposed of with the following order: -

ORDER

(i) Respondents shall update the “IMV Eligible List-2023” published on 23.9.2023 by entering the remarks against the name of the present applicants evidencing that they had worked in ‘Tribal area’, before issuance of the orders of transfer.

(ii) The Original Application stands disposed of in the aforesaid terms.

(iii) There shall be no order as to costs.
