3. During the course of the arguments, it is informed that the applicant is facing the departmental enquiry and the same has not yet been concluded. It is further submitted that a criminal case has been registered against the applicant. It is also brought to our notice that the applicant has approached the Hon'ble High Court of Judicature at Bombay, Nagpur Bench for quashment of F.I.R. registered against him and it is still pending. It is submitted that, though the applicant is entitled for promotion to the next promotional post, on the ground that the departmental enquiry is pending, his name has not been included in the list of the Officers to be promoted to the next promotional post and the decision of the Departmental Promotion Committee is kept in a sealed envelope.

4. In view of the aforesaid facts, it does not appear to us that any indulgence is required by this Tribunal or any order is to be passed in the present matter. No prejudice is likely to be caused to the applicant as the D.P.C. has considered the name of the applicant for promotion to the next promotional post and its decision is kept in a sealed envelope. Implementation of the decision kept in sealed envelope would depend upon the outcome of the
