ORDER

- 1. Heard Shri M. D. Lonkar, learned Counsel for 'Applicant-Intervenor', Shri A. V. Bandiwadekar, learned Counsel for 'Applicant' and Shri A. J. Chougule, learned Presenting Officer for 'Respondents'.
- 2. The learned Advocate for 'Applicant-Intervenor' seeks dismissal of O.A.No.282/2024 filed by 'Applicant' on grounds of 'Suppression of Material Facts' and further seeks directions to implead 'Applicant -Intervenor' as 'Respondent No.5'.
- 3. The learned Advocate for 'Applicant-Intervenor' contended that 'Applicant' has deliberately and intentionally not impleaded 'Applicant-Intervenor' as 'Respondent No.5' in order to misuse the process of law to obtain 'Interim Relief' behind the back of 'Applicant-Intervenor'.
- 4. The learned Advocate for 'Applicant-Intervenor' contended that O.A.No.282/2024 suffers from 'suppressio veri' and 'suggestio falsi' as there was intentional 'Suppression of Material Facts' viz (i) Rural Development Department Government Order dated 23.02.2024 about transfer of 'Applicant-Intervenor' to post of 'Additional CEO ZP Thane' as it was known to Applicant (ii) Applicant had made request application on 26.02.2024 for modification of Rural Development Department Government Order dated 23.02.2024 to seek transfer to post of 'PD-DRDA, Palghar'.

- 5. The learned Advocate for 'Applicant-Intervenor' was heard at length on issues relating to 'Suppression of Material Facts' by Applicant as also to implead 'Applicant-Intervenor' as 'Respondent No.5' and to vacate 'Interim Order' dated 29.02.2024.
- 6. The learned Advocate for 'Applicant-Intervenor' emphatically stressed that Rural Development Department Government Order dated 23.02.2024 had been uploaded on 'Website' on 23.02.2024; as Applicant had already been transferred from post of 'Additional CEO ZP Thane'. The 'Applicant-Intervenor' had also taken charge of post of 'Additional CEO ZP Thane' on 26.02.2024 and before doing so, she had made 'Telephone Calls' and sent 'WhatsApp Messages' to Applicant
- 7. The learned Advocate for 'Applicant-Intervenor' insisted on dismissal of O.A.No.282/2024 on grounds of 'Suppression of Material Facts' and presented some judgments in this regard of Hon'ble Supreme Court of India.
- 8. The contention of learned Advocate for 'Applicant-Intervenor' made it imperative to look for clinching evidence relating to 'Suppression of Material Facts' by Applicant in O.A.No.282/2024 especially about the actual 'Date and Time' of uploading on 'Website' of Rural Development Government Order dated 23.02.204 by which 'Applicant-Intervenor' has been transferred to post of 'Additional CEO ZP Thane'.



- 9. The learned PO as per directions given during hearing of MA No.154/2024 submitted copy of 'Under Secretary (Technical), Directorate of Information Technology' letter dated 18.03.2024 addressed to 'Under Secretary, Rural Development Department' with which is attached copy of 'email' sent on 23.02.2024 by 'Shri Ajinkar Narkar' serving in 'Rural Development Department' to 'Shri Vipul Kothawade' working in 'Directorate of Information Technology' for uploading on 'Website' of Rural Development Government Order dated 23.02.2024 about transfer of 'Applicant-Intervenor' to post of 'Additional CEO ZP Thane'.
- 10. The 'e-mail' sent on 23.02.2024 by 'Shri Ajinkar Narkar' serving in 'Rural Development Department' was to convey that Rural Development Department Government Order dated 23.02.2024 about transfer of 'Applicant -Intervenor' to post of 'Additional CEO ZP Thane' be uploaded on 'Website' to place it in 'Public Domain'. The reply 'email' sent by "Shri Vipul Kothawade' working in 'Directorate of Information Technology' on 23.02.2024 contains brief cryptic words "It's Done". So, question naturally arises whether this reply 'e-mail' sent by 'Shri Vipul Kothawade' working in 'Directorate of Information Technology' on 23.02.2024 could be admissible as necessary and sufficient evidence to conclusively establish that Rural Development Department Government Order dated 23.02.2024 about transfer of 'Applicant- Intervenor' to post of 'Additional CEO ZP Thane' was indeed uploaded on 'Website' on 23.02.2024 as has been claimed by 'Applicant-Intervenor'.

- 11. The contentious issue relating to 'Suppression of Material Facts' is primarily relating to actual 'Time and Date' of uploading on 'Website' of 'Rural Development Department Government Order' dated 23.02.2024 regarding transfer of 'Applicant-Intervenor' to post of 'Additional CEO ZP Thane'. The learned Advocate for Applicant emphatically denied that Rural Development Department Government Order dated 23.02.2024 had indeed been uploaded on 'Website' on 23.02.2024. Per Contra, learned Advocate for 'Applicant-Intervenor' persistently affirmed on the basis of the reply 'e-mail' that it was definitely done on 23.02.2024.
- 12. The arguments of learned Advocate for 'Applicant-Intervenor' was centered around 'Suppression of Material Facts'. Hence, it became necessary to delve deeper to examine 'Electronic Evidence' relating to uploading on 'Website' of Rural Development Government Order dated 23.02.2024 about transfer of 'Applicant-Intervenor' to post of 'Additional CEO ZP Thane'.
- 13. The 'Section 65A' of 'Indian Evidence Act, 1872' provides special provision for electronic records to be considered as evidence, while 'Section 65B' governs their admissibility under 'Indian Evidence Act 1872'. Accordingly, when electronic records are submitted as evidence, they are to be treated as "Documents" under the 'Indian Evidence Act, 1872'. The purpose of 'Section 65A' and 'Section 65B' of 'Indian Evidence Act 1872' is to facilitate use of 'Electronic Evidence' in 'Legal Proceedings'. Accordingly, original information stored within computers are to be considered as 'Primary Evidence'. Copies derived from it on the other hand; are to be treated as



'Secondary Evidence'. Further; 'Certificate' under 'Section 65B' is necessary only when presenting 'Electronic Evidence' as 'Secondary Evidence'. If original electronic record, which serves as 'Primary Evidence' is produced, then submission of 'Certificate' is not required. The owner of the computer can directly introduce the original electronic record as 'Primary Evidence' by testifying that they own or operate the electronic devices where the information is initially stored.

- 14. The "Documents" under 'Section 65A' and 'Section 65B' of 'Indian Evidence Act 1872' though of greater evidential value with regard to contention of 'Suppression of Material Facts' are nestled in 'High End Servers' owned by 'National Informatics Centre (NIC)'. Thus, against this backdrop; the powers vested by 'Section 22(3)(b) of 'Administrative Tribunals Act, 1985' came to be exercised for discovery and production of such "Documents".
- 15. The 'Director of Information Technology, GOM' was accordingly informed to depute 'Competent Technical Officer' to submit 'Electronic Evidence' about uploading of information on various 'Websites' in observance of provisions of 'Section 4' of 'The Right to Information Act 2005'. The information so embedded in 'High End Servers' owned by 'National Informatics Centre (NIC)' thereupon forms valuable evidence as "Documents" admissible under 'Section 65A' and 'Section 65B' of 'Indian Evidence Act 1872'.

- 16. The 'Competent Technical Officer' deputed by 'Director of Information Technology, GOM' submitted printouts of 'Electronics Evidence' stored in 'High End Servers' of 'National Informatics Centre (NIC)' which are marked as 'Court Exhibit 'A' and 'Court Exhibit 'B' and now placed with 'M.A.No.154/2024'. The 'Competent Technical Officer' on query explained the meaning of words used in 'Header Captions' of columns of 'Court Exhibit A' and 'Court Exhibit B' which are (a) Title (b) File Name (c) File Size (d) Issue Date (e) Created Date (f) Last Updated (g) IP Address (h) Description. On query, he said that 'Electronic Evidence' admissible under 'Section 65A' and 'Section 65B' of 'Indian Evidence Act 1872' when printed from 'High End Servers' of 'National Informatics Centre (NIC)' to become "Documents"; however does not show actual 'Date and Time' of 'First Updation' but only shows actual 'Date and Time' of 'Last Updation' in receipt of all files including those relating to 'Applicant' in O.A.No.282/2024 and 'Applicant-Intervenor' in MA No.154/2024.
- 17. The perusal of 'Court Exhibit A' and 'Court Exhibit B' interestingly establishes that while all other files relating to many 'Government Resolutions' or 'Government Orders' which had been received from various 'Administrative Departments' on 23.02.2024 came to be immediately uploaded on 'Website' by 'National Informatics Centre (NIC)' including Rural Development Department Order dated 23.02.2024 about transfer of Applicant O.A. 282/2024 to post of 'PD-DRDA Jalna'; no 'Electronic Evidence' printed on "Documents" shows that 'Last Updation' happened on 23.02.2024 itself of



file regarding Rural Development Government Order dated 23.02.2024 about transfer of 'Applicant-Intervenor' to post of 'Additional CEO ZP Thane'.

- 18. The claims of 'Applicant-Intervenor' that indeed there was 'Suppression of Material Facts' by Applicant in O.A.No.282/2024 with regard to knowledge about uploading on 'Website' on 23.02.2024 itself of Rural Development Government Order dated 23.02.2024 about transfer of 'Applicant-Intervenor' to post of 'Additional CEO ZP Thane' is thus not established beyond all reasonable doubts. The "Documents" under 'Section 65A' and 'Section 65B' of the 'Indian Evidence Act, 1872' shows that Rural Development Government Order dated 23.02.2024 about transfer of 'Applicant-Intervenor' to post of 'Additional CEO ZP Thane' was uploaded on 'Website' by way of 'Last Updation' at 11.46.29 hours on 01.03.2024 by 'National Informatics Centre (NIC)' as shown in 'Court Exhibit A' and 'Court Exhibit B' now placed with M.A.No.154/2024. Hence, claims of 'Applicant-Intervenor' in MA 154/2024 about 'Suppression of Material Facts' are not conclusively established so as to necessitate outright dismissal of O.A. No.282/2024 without giving any further opportunity to Applicant.
- 19. The fact however remains that Applicant in O.A.No.282/2024 did not disclose that she had submitted request application to Rural Development Department on 26.02.2024 to seek modification of her transfer from post of 'PD-DRDA, Jalna' to post of 'PD-DRDA, Palghar', as it now stands established by averment in 'Para 8' of 'Affidavit in Reply' dated 04.03.2024 filed by 'Under Secretary, Rural Development Department'. The request of Applicant made on 26.02.2024 for modification of transfer to post of 'PD-DRDA Palghar' had been

recommended by 'CSB' in meeting held on 26.02.2024 and affirmative proposal had been submitted thereafter to 'Competent Transferring Authority' for modification of transfer of Applicant to post of 'PD-DRDA Palghar'. However, act of Applicant in not specifically mentioning about the request application submitted on 26.02.2024 to Rural Development Department cannot be categorized as 'Suppression of Material Facts' as this communication was made at 'Personal Level' by Applicant and its outcome may not have been known to Applicant at the time of filing O.A.No.282/2024 on 29.02.2024. Further, in no case would the final outcome of request made by Applicant on 26.02.2024 be prejudicial to 'Applicant-Intervenor' as she has already been transferred to post of 'Additional CEO ZP, Thane' ostensibly while serving earlier on post of 'PD-DRDA, Palghar'.

20. The Applicant in O.A.No.282/2024 had on 26.02.2024 reported to Rural Development Department that 'Applicant-Intervenor' has come to take charge of post of 'Additional CEO ZP Thane' but copy of Rural Development Department Government Order dated 25.02.2024 about transfer of 'Applicant-Intervenor' to post of 'Additional CEO ZP Thane' was not available on 'Website'. The Rural Development must have thereafter ascertained the factual position because Rural Development Department had again sent 'e-mail' to Shri Vipul Kothawade working in 'Directorate of Information Technology' at 11.32 hours on 01.03.2024 informing "कृपया सोबत जोडलेला शासन आदेश शासकीय संकेतस्थळावर अपलोड करावा, हि विनंती''. Thereupon, uploading of Rural Development Government Order dated 23.02.2024 about transfer of 'Applicant-Intervenor' to post of 'Additional CEO ZP Thane' happened on

'Website' at 11.46.29 hrs on 01.03.2024 as reflected in 'Court Exhibit A' and

'Court Exhibit B' now placed with MA No.154/2024.

The claims of 'Applicant-Intervenor' in M.A.No.154/2024 regarding

'Suppression of Material Facts' by Applicant in O.A. No.282/2024 is therefore

not proven by "Documents" admissible under provisions of 'Section 65A' and

'Section 65B' of 'Indian Evidence Act 1872'. Nonetheless, the 'Applicant-

Intervenor' in MA No.154/2024 having been posted in place of Applicant in

OA No.282/2024 as 'Additional CEO ZP Thane' must be impleaded as

'Respondent No.5' for observance of the "Principles of Natural Justice".

22. The M.A.No.154/2024 is thus partly Allowed. The Applicant is

accordingly directed to implead 'Applicant-Intervenor' as 'Respondent No.5' in

O.A.No.282/2024 within 'One Week'.

23. The Original Application No.282/2024 is adjourned to 26.04.2024.

- Heard Shri A.V. Bandiwadekar, learned Advocate for the Applicant and Shri A.J. Chougule & Shri A.D. Gugale, learned Presenting Officer for the Respondents.
- 2. Learned Advocate for Applicant states that Applicants who were working on the post of 'Assistant Police Inspector' were promoted to post of 'Police Inspector'. Thereupon; allotment of 'Revenue Divisions' were made to them as per 'Maharashtra Government Allotment of Revenue Divisions for appointment by nomination and promotion to the posts in Group A and Group B (Gazetted and Non-Gazetted) Rules, 2021' by way of 'D.G.P. Maharashtra State' Order dated 15.03.2024. The Applicants have been allotted to 'Konkan-2 Division'.
- 3. Learned Advocate for Applicant further states that grievance of Applicant is that though they have been allotted to 'Revenue Division' of choice which is 'Konkan 2 Division'; but their requests about choice of 'Police Establishments' were not considered in 'D.G.P. Maharashtra State' Order dated 15.03.2024.
- 4. Learned Advocate for Applicant thereupon states that by 'D.G.P. Maharashtra State' letter dated 29.12.2023 choice of 'Police Establishment' had been were sought from officers promoted to post of 'Police Inspector'.

Tribunal's orders

- 5. Learned Advocate for Applicant then draws attention to 'D.G.P. Maharashtra State' letter dated 06.03.2024 in which it is mentioned that those 'Police Inspectors' who could not get 'Revenue Divisions' of their choice; have all been assigned to 'Konkan 2 Division'.
- 6. Learned P.O. states that 'D.G.P. Maharashtra State' Order dated 15.03.2024 which was in respect of (i) 'Promotion' to 'Police Inspector' (ii) 'Allotment' of 'Revenue Divisions' and (ii) 'Assignment' of 'Police Establishments' has been done as per provisions of 'Maharashtra Government Allotment of Revenue Divisions for appointment by nomination and promotion to the posts in Group A and Group B (Gazetted and Non-Gazetted) Rules, 2021' and provisions of 'Section 22N' of 'Maharashtra Police Act 1951'.
- 7. The implementation 'Maharashtra Government Allotment of Revenue Divisions for appointment by nomination and promotion to the posts in Group A and Group B (Gazetted and Non-Gazetted) Rules, 2021' is required to be done in both letter and spirit and thus it becomes pertinent to observe that as per provisions of 'Para 6(5)(b)' captioned as 'Revenue Division Allotment by Rotation' the entire procedure should have been completed in prescribed sequence of 'Nagpur, Amaravati, Aurangabad, Nashik, Konkan-1, Konkan-2 & Pune Divisions'. However, it appears that this was given go by 'D.G.P. Maharashtra State' becasue all 'Police Inspectors' who did not get 'Revenue Divisions' of their choice were bunched together and thereupon assigned only to 'Konkan - 2 Division'. The decision so taken by 'D.G.P. Maharashtra State' 'primacontravenes provision of 'Rules notwithstanding the fact that there were 426 'Vacant Posts' of 'Police Inspectors' in 'Konkan - 2 Division' alone; as against 681 'Vacant Posts' in all 'Revenue Divisions' put together. The above skewedness in distribution of 'Vacant Posts' of 681 'Police Inspectors' primarily is on account of location of higher number of bigger 'Police Establishments' in 'Konkan - 2 Division' as compared to those in other 'Revenue Divisions'.
- 8. The availability of 426 'Vacant Posts' of 'Police Inspectors' alone cannot be the reason for assignment of all those who did not get 'Revenue Divisions' of their choices to only 'Konkan 2 Division'. This needs to be

examined by 'D.G.P. Maharashtra State' because contention made by Applicants is that those who were not entitled at all to be allotted to 'Konkan - 2 Division' have not only got it due to distorted outcomes from contravention of 'Rule 6(5)(b)'; but even got their choices of 'Police Establishments' as per recommendations of 'P.E.B.' under 'Section 22N' of 'Mumbai Police Act, 1951, which had infact been sought by Applicants who were to get 'Konkan - 2 Division' based on implementation of 'Rule 6(5)(a)' of 'Maharashtra Government Allotment of Revenue Divisions for appointment by nomination and promotion to the posts in Group A and Group B (Gazetted and Non-Gazetted) Rules, 2021'.

- 9. The office objections, if any, are to be removed and court fees to be paid, if not already paid.
- 10. Issue notice before admission returnable on 10.04.2024.
- 11. Applicant is authorized and directed to serve on Respondent intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Private service is allowed. Respondents are put to notice that the case may be taken up for final disposal at the stage of admission hearing.
- 12. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

- 1. Heard Shri A.V. Bandiwadekar, learned Advocate for the Applicants, Smt. Archana B.K., learned Presenting Officer for the Respondent No.1 and Smt. K.S. Gaikwad, learned Presenting Officer for the Respondents No.2.
- 2. Learned P.O. as per directions given on 05.03.2024 presents copy of 'Home Department' G.R. dated 24.07.2023 by which 'Commissioner of Police, Greater Mumbai' has been permitted as temporary measure to engage take '3000 Security Personnel' on 'Contract Basis' from 'Maharashtra State Security Corporation (MSSC)'.
- 3. Learned P.O. further states that the 3000 'Security Personnel' who have been permitted to be engaged on 'Contract Basis' may not be adequately trained to work as 'Police Head Constable Wireless Operators' in 'Major Control Room' and 'Regional Control Room' in establishment of 'Commissioner of Police, Greater Mumbai'.
- 4. The recruitment of 'Police Head Constable Wireless Operators' have been unduly delayed because revised recruitment rules are yet to be finalized by the 'Home Department'. However, on account of delay in finalization of revised recruitment rules; large number of vacancies have arisen in posts of 'Police Head Constable Wireless Operators' in most of the 'Police Establishments' including that of 'Commissioner of Police, Greater Mumbai', as has also been fairly admitted in 'Affidavit-in-Reply' filed on 24.11.2023 by 'D.G.P. Police Connection and Information Technology, South Zone, Mumbai.'
- 5. The 'Commissioner of Police, Greater Mumbai' was thereupon informed to explore some temporary options which can be considered for deployment of trained manpower to hold the vacant posts of 'Police Head Constable Wireless Operators' in 'Major Control Room' and 'Regional Control Rooms'. Further it was also observed that the entire issue being an administrative matter can be best resolved through better coordination between (i) 'Additional Director General of Police & Director Wireless

and Transport Maharashtra State, Pune' and (ii) 'Commissioner of Police, Greater Mumbai'.

- 6. The 'Additional Director General of Police.' & 'Director Wireless and Transport, Maharashtra State, Pune' who is heading the 'Specialized Agency' was thus expected to submit some 'Plan of Action' in this regard based on consultations with 'Commissioner of Police, Greater Mumbai' and upon concurrence of 'D.G.P. Maharashtra State'.
- 7. The facts and circumstance of the cases of Applicant thus makes its imperative to nudge the 'Additional Director General of Police.' & 'Director Wireless and Transport, Maharashtra State, Pune' to forthwith examine whether it would be viable and feasible in 'Interim Period' atleast till the revised recruitment rules of 'Police Head Constable -Wireless Operator' are finalized by 'Home Department' to seek 'Special Permission' to take on 'Contract Basis' from 'Maharashtra State Security Corporation (MSSC)' such 'Security Personnel' who may be registered from amongst 'Ex-Servicemen' having 'Basic Training' in 'Wireless Operations' while serving in 'Indian Army'. The temporary deployment on vacant posts of 'Police Head Constable -Wireless Operators' of such 'Security Personnel' if available with 'Maharashtra State Security Corporation (MSSC)' will enable implementation albeit rather belatedly of the 'Transfer Orders' dated 30.09.2022 and 20.10.2022. Needless to mention that such proposal if submitted by 'Additional Director General of Police.' & 'Director Wireless and Transport, Maharashtra State, Pune' through 'D.G.P. Maharashtra State' will deserve prompt consideration of the 'Home Department'.
- 8. The learned Advocate for Applicant is thus directed to make the (i) 'Additional Chief Secretary, Home Department' (ii) 'Director General of Police, Maharashtra State' and (iii) 'Commissioner of Police, Greater Mumbai' respectively as 'Respondent No.3'; 'Respondent No.4' & 'Respondent 5'; so as to facilitate expeditious redressal of grievances of Applicants in accordance with provisions of 'Section 22(2)' of the 'Administrative Tribunals Act, 1985'.

- 1. Heard Shri S.N. Biradar, learned Advocate for Applicant and **Ms. S.P. Manchekar**, learned CPO for Respondents.
- 2. The Applicant is permanent employee of Tribal Development Department. Initially, on 07.08.2009, he was appointed as 'Research Assistant'. On 26.09.2018, Applicant was promoted to post of 'Research Officer'.
- 3. The learned Advocate for Applicant submits that Applicant has secured 2 point less marks from cut-off marks. The Applicant is from 'Open Category'. He submits that 7 posts are to be filled-in of 'Research Senior Officers'. He submits that out of 41 candidates, 30 candidates were found ineligible in documents verification and thus, the list of only 11 candidates is sent for 'Interview' for filling-up 7 posts of 'Research Sernior Officers'. He further submits that ratio 1:5 is not maintained and therefore, list is required to be revised. He then submits that 'Wait List Candidates' are to be called and previous list is to be revised.
- 4. We are of the view that proper ratio as laid down in Rule 9 is not followed; because many candidates on the ground that they do not possess proper documentary proofs are eliminated before 'Interview' and hence the ratio is not maintained.
- 5. We would like to know from Secretary, MPSC why the procedure of verification of documents is followed after publishing the list of

'Eligible Candidates'. The Secretary, MPSC be present on next date i.e. on 05th April, 2024.

- 6. Issue notice returnable on 05.04.2024.
- 7. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

- 1. Heard Shri D.B. Khaire, learned Advocate for Applicant and Ms. S.P. Manchekar, learned CPO for Respondents.
- 2. The Applicant is Transgender who wants to appear for Examination for post of 'Police Constable'. She prays that by way of age relaxation, she be allowed to appear for Examination conducted by 'Additional Director General (Training)' and last date of filling-up the Forms for recruitment is 15.04.2024.
- 3. The learned CPO submits that the issue of granting granting reservation to Transgenders in recruitment process is pending before Hon'ble Bombay High Court, as the order of this Tribunal directing to grant reservation in recruitment to Transgenders in OA No.1121/2022 with OA No.401/2023 and OA No.928/2023 is challenged before Hon'ble Bombay High Court.
- 4. The learned Advoate for Applicant submits that Applicant had approached this Tribunal time to time for seeking small orders even for acknowledging the identity of 3rd Gender while filling-up the Forms for Examination conducted by MPSC or Government.
- 5. The learned Advocate for Applicant further submits that lot of time and energy of Applicant is consumed. He points out that the candidates who are in Horizontal Reservation especially 'Ex-Servicemen/Sportsmen' will be given relaxation even upto the age of 45, and therefore, Applicant prays that she be given age relaxation only for

want chance for recruitment which is going to be conducted pursuant to 'Recruitments of 2023'.

- 6. We confirmed from learned CPO about any stay granted by Hon'ble Bombay High Court to our order in abovementioned OAs by giving some age relaxation, fees, etc. to Transgenders appearing in public recruitment and we are informed that no such stay is granted as on today by Hon'ble Bombay High Court.
- 7. In view of submissions made by both parties and taking into consideration facts and circumstances of the case, we are of view that 'Interim Relief' be granted to Applicant, which is as follows:-

The Applicant is allowed to fill-up the Form as per Advertisement dated 05.03.2024 for Examination for the post of 'Police Constable' in recruitment process of 2023 conducted by 'Additional Director General (Training)'.

- 2. The Applicant who aspires to be appointed to the post of Senior Research Officer, Group-A (Grade-II). He has applied in EWS General Category pursuant to Advertisement dated 11.08.2020. This pertains to eligibility of candidates insofar as experience is concerned.
- 3. As per Clause 4.5 of Advertisement is concerned, not less than 3 years experience in the field of training, Social Welfare or Tribal Research is required.
- 4. The learned Advocate for Applicant submits that Applicant has produced the Certificate of Experience dated 03.01.2024. He relied on Exh.A-6' i.e. Certificate of Experience dated 05.01.2024 and also relied on Exh.A-2' i.e. Certificate of Experience dated 03.01.2024 in the field of Tribal, Social Welfare or Tribal Research.
- 5. The learned Advocate for Applicant relied on Order dated 26.03.2024 passed by MAT, Aurangabad Bench in MA No.128/2024 in OA St. No.733/2024 [Balasaheb M. Kothule & Anr. Vs. State of Maharashtra & Ors.]. In this order, Single Bench Judge of MAT, Aurangabad Bench has addressed Clause No.4.5 on which the entire argument is based.

During the pendency of O.A. in August, 2023 certain information was sought by the Applicant through RTI and pursuant to the information received under RTI in the year 2023 the Applicant found it necessary to carry out certain amendments to bring the facts during the pendency of O.A. and therefore there is no delay as such.
- 4. Learned P.O. opposes the amendment application (M.A.) mainly on the ground of delay.
- 5. Considered submissions of both the parties. Apparently there is delay, but however considering the explanation given by the learned Counsel that the RTI information was sought when the O.A. was pending and therefore the applicant filed this amendment application.
- 6. In view of above, M.A. is allowed. Amendment be carried out within one week from today. Amended copy to be served on the Respondents forthwith. Respondents may file reply to the amended portion within three weeks.
- 7. M.A. disposed of. O.A. adjourned to 18.04.2024.
