3. Learned Chief Presenting Officer has sought time for filing affidavit in reply. He has opposed for granting interim relief as has been prayed by the applicant. He further submitted that the entire selection process cannot be stalled.

4. I have duly considered the submissions advanced on behalf of the parties. The applicant has certainly made out a *prima facie* case. It *prima facie* appears unacceptable that in the midst of the selection process Commission has modified criteria of eligibility insofar as educational qualification is concerned. In the circumstances, I deem it appropriate to pass the following order: -

It is the contention of the applicant that the order of termination was served late on the applicant and was not even aware that such order has been passed when he was discharging the duties at Primary Health Centre in Akkulkuwa Taluka. It is further contended that the reason, which has been assigned for his termination is improper and the opportunity needs to be given to the applicant to justify his case. Learned counsel appearing for the applicant submitted that in the meanwhile some correspondence was made by the applicant with the authorities and respondent No. 3 has also recommended to respondent No. 2, to consider the case of the applicant. In the circumstances, the applicant has become late in approaching this Tribunal. Learned counsel submitted that the applicant be given an opportunity to prosecute his case on merit. It is further submitted that

the delay occurred is not deliberate, intentional or with mala fide reasons.

3. Learned Presenting Officer has submitted for passing appropriate order. Learned counsel appearing for the respondent No. 4 opposed for condoning the delay. He pointed out that averment in the O.A. reveals that the order of termination was served on the applicant at the end of August, In the circumstances, within next one year the 2018. applicant must have approached this tribunal, whereas the O.A. has been filed on 16.11.2019. He further submitted that knowing that the application is not within the period of limitation, no application for condonation of delay was filed and it came to be filed on 3.2.2020. Considering the conduct of the applicant, no equitable relief deserves to be granted in his favour.

4. I have carefully considered the submissions advanced on behalf of the parties. It is true that the applicant did not file application for condonation of delay along with O.A. Though it is contended on behalf of the applicant that the applicant was *bona-fide* believing that he has filed application within the period of limitation, the same cannot be accepted. From the record it appears that the order of termination was served on the applicant some time at the end of August, 2018. The applicant has filed the O.A. in the month of November, 2019. Thus, admittedly, there is delay of 56 days in filing O.A. From the record it reveals that in the meanwhile period the

applicant ventilated his grievance at the departmental level. It, therefore, cannot be said that the applicant was negligent in prosecuting his claim. *Prima facie* there appears no mala fide on the part of the applicant in approaching Tribunal late. Moreover, the delay is not of a longer period. It is well settled that the matters are to be decided on merits and shall not be thrown on technicalities. The applicant deserves to be given an opportunity to prosecute his grievance on merits. I am, therefore, inclined to allow the application for condonation of delay. Hence, the following order: -

(i) The application for condonation of delay is allowed. The delay is condoned.

(ii) The Original Application be registered in accordance with law.

(iii) There shall be no order as to costs.
