The issue naturally is with regard to the compliance with relevant provision of Transfer Act. particular file which is presented for my perusal in name of reason has mentioned in Marathi "तकारीवर कार्यवाही सुरू आहे." Now, the file showing precisely as to what are the compliant is not produced. I am told that the said file is at Pune. In my opinion, when the matter is under judicial scrutiny, the most important aspect is as to whether at the time of effecting the transfer the issues of special reasons and exceptional circumstances were addressed. If the compliant related to the period before the Applicant joined his present posting then obviously the present order of the transfer would become vulnerable. In my opinion, interim relief may be granted today with liberty to the Respondents as indicated herein. It is made clear further that in view of the order or otherwise the Applicant has been relieved, he will have to be reposted. The order herein impugned in so far as relates to the

Applicant is hereby stayed till the date next to the filing of the Reply and in case the Applicant has been relieved, he be reposted at the same place where he has been transferred from. Compliance within one week from today.

Liberty is reserved for the Respondents to move with a reasonable advocate notice to the Advocates and Tribunal for any medication and vacation of this interim relief.
