- 3. Applicant was appointed as Cleaner/Sweeper in the office of Respondent. While in service he was dismissed from service from 02.11.2015. However in appeal, order of dismissal was modified and it was reduced to order of compulsory retirement passed on 08.06.2018. The Applicant has filed O.A. 338/19 challenging the dismissal order and also compulsory retirement. On this background notice was issued by Deputy Commissioner of Police directing the Applicant to vacate the quarter which was allotted to him while he was in service.
- 4. Thus apparently, Applicant is in unauthorized possession of the quarter for more than 4 years. Prayer for allowing him to continue in the quarter till decision of O.A. No. 338/19 is not at all sustainable, as he has no right much less legal right to continue the possession of quarter.
- 5. As such O.A. is not maintainable and therefore dismissed summarily.
