The learned CPO based on information 5. from officers of the Medical Education & Drugs refers to Notification dated Department 16.08.2023, which is of Undergraduate Medical Education Board under 'National Medical Commission' wherein in Chapter-1, the names of 21 departments which are mandatorily to be included in every Medical Colleges which carry out teaching of Undergraduate Medical Courses have been mentioned. Learned CPO states that name of 21 departments does not include Transfusion Medicine. She also refers Schedule 1-Para B(10) under the caption of 'Blood Bank' wherein it is mentioned as under :-

The Blood Transfusion Services should be under the Administrative Control of the teaching Department of Pathology of the Medical Colleges when there is no separate Department of Transfusion Medicine".

6. The learned CPO also mentions about the ongoing Public Interest Litigation bearing Stamp No.16 of 2021 with Sou Motu Public Litigation No.1 of 2023 in Hon'ble High Court of Judicature at Bombay, wherein directions have been given about filling-up of vacancies in the Public Health Department and Medical Education and Drugs Department expeditiously by MPSC.

Learned Advocate for the Applicants then 7. that Advertisement No.135/2023 to stated 262/2023 which was published by MPSC on 05.12.2023 is for recruitment of Assistant Professors Group-B in 6 New Medical Colleges at Dharashiv, Alibagh, Sindhudurg, Nandurbar, Parbhani and Satara and includes 55 posts under 'Pathology'. However, these 55 posts of Assistant Professors are not for those who have specialized 'Immunohematology and Blood as MD in Transfusion'. She also stated that Applicants are not in a position to apply for the post of Assistant Professors Group-B for 'Pathology' because required Educatoin Qualifications specified are Pathology/P.Hd Pathology/D.Sc 'MD Pathology/DNB' and does not include 'MD in Immunohematology and Blood Transfusion'.
