The learned counsel, however, has failed in bringing to my notice any provision showing that when one application seeking appointment on compassionate ground presented by one legal heir of the deceased is pending for consideration, any other legal heir of the deceased can also file the application and that it can be considered by the Government.

3. In the circumstances, it is difficult to accept the request made by the applicant in the present application. It is not in dispute that one legal heir has filed application praying for compassionate appointment and same is under consideration. In the circumstances, no second application is liable to be entertained by the Government. Hence, no direction also can be issued to the respondents to consider the representation of the present applicant.
