2. The applicant has been transferred from Osmanabad to Beed. It is the grievance of the applicant that his parents are having some ailment and more particularly his father is suffering from paralysis and his treatment is being done at Dr. Kasbe's Multi Specialty Hospital at Ausa, District Latur. Learned counsel for the applicant submitted that though the applicant is due for transfer since he has completed the tenure of about 5 years at Osmanabad, he has made a representation before transfer orders are issued seeking retention for one year on the ground of sickness of his father by paralysis. The learned counsel further submitted that even after the transfer orders are issued one more representation is made by the applicant

seeking his transfer at Latur where the post is vacant so that he can conveniently get treatment for his father. The learned counsel submitted that in spite of the aforesaid difficulties ignoring the said difficulties, the applicant has been transferred at Beed. Learned counsel in the circumstances, has prayed for stay to the order of transfer till decision of the present O.A.

3. Shri M.S. Mahajan, learned C.P.O. has opposed for grant of any interim relief. Learned C.P.O. submitted that one Mr. D.S. Chame has already given posting in place of the applicant and he has been relieved from the existing post. The learned C.P.O. submitted that the Government servant has to first obey the order of transfer and it is always open for him to make a representation which can be considered by the authorities. The learned C.P.O. in the circumstances, opposed for interim relief and prayed for time for filing affidavit in reply by the respondents.

4. I have duly considered the submissions made on behalf of the applicant and the respondents. I have also gone through the documents placed on

record by the applicant which documents pertaining to the illness of the parents of the applicant. The applicant is seeking his transfer at the place near to Ausa, so that he can conveniently get the treatment to his father who is suffering from paralysis. As mentioned in the application the applicant alone is owing the responsibility of his parents. The representation made by the applicant is also filed along with O.A.

5. There appears prima-facie substance in the request made by the applicant seeking his transfer at some place near to Ausa where posts are vacant. However, it has to be stated that when in the annual general transfers the transfers are made the Government servant is expected to join at the and thereafter to transferred place make а If the difficulties are genuine the representation. representations are normally considered by the competent authorities. Without consideration of the said representation by the competent authorities the Tribunal cannot directly usurp the power of the said authorities. It has to be further stated that if the grievance is not appropriately redressed and if it is

noticed that there are mala fides in not considering the request of the applicant, the Tribunal can certainly intervene. However, since one D.S. Chame has been transferred in place of the applicant and he has been already relieved from his existing post, it may not be proper at this juncture to stay the effect and operation of the impugned order. The applicant has already made a representation. The respondents are directed to consider the said representation of the applicant and more particularly by considering the reason of ailment of his father which is one of the preferred grounds for considering such request.

6. Learned counsel for the applicant submits that the post at Latur on which Shri Chame was working is vacant and according to the instructions of the applicant no one has claimed the said post. If it be so the learned C.P.O. shall take instructions and make a statement on 3.7.2023 so that further request made by the applicant can be considered.

7. With the observations as above issue notice to the respondents, returnable on 3.7.2023.
