The present Original Application is filed seeking to quash and set aside the impugned order of transfer of the respondent No. 3 dated 25.07.2022 (Annexure A-2) issued by the respondent No. 1 modifying the order of posting on promotion given to the respondent No. 3 by the order dated 21.10.2021 (Annexure A-3) resulting into applicant's probable mid-term transfer from the post of Superintending Engineer, Public Works Circle, Nanded and seeking interim relief of stay to the execution and implementation of the said impugned order dated 25.07.2022 (Annexure A-2).

3. The applicant is working as the Superintending Engineer in the office of Superintending Engineer, Public Works Circle, Nanded since his earlier transfer order dated 28.12.2018 (Annexure A-1). By now he has completed tenure of about three and half years on the present post. The apprehension of the applicant is that he is likely to be transferred mid-term from his present posting in view of the impugned order of

transfer dated 25.07.2022 (Annexure A-2), as by the said order the respondent No. 3 is transferred on promotion on the post held by the applicant. In fact, the said respondent No. 3 was ordered to be transferred on promotion by order dated 21.10.2021 (Annexure A-3), whereby he was transferred on the post of Superintending Engineer (Civil), Maharashtra Maritime Board, Mumbai.

4. It seems from the impugned order that the respondent No. 3 did not join at the said transferred place of Maharashtra Maritime Board, Mumbai. His said promotional and transfer order dated 21.10.2021 is modified by issuing the impugned order of transfer dated 25.07.2022 (Annexure A-2).

5. Learned Advocate for the applicant invited my attention to clause 2 of the transfer order dated 25.07.2022 (Annexure A-2), which is as follows :-

6. In view of above, the learned Advocate for the applicant submitted that the applicant has strong apprehension that he is likely to be transferred from his present post mid-term causing inconvenience and hardship to him.

7. Learned Advocate for the applicant also invited my attention to the statement made in para No. 8 of O.A., wherein it is stated as follows :-

“8.....Apart therefrom, on the basis of the same facts and circumstances and the grounds the applicant also deserves grant of interim relief as prayed for herein below in view of the fact that as on today he is holding the charge of his post of Superintending Engineer, P.W. Circle, Nanded and he has not handed over the same to anybody else muchless to the respondent No. 3.”

8. Learned C.P.O. on the other hand apposed the submissions made on behalf of the applicant and submitted that he would seek instructions from the respondent Nos. 1 and 2 and will file affidavit in reply and therefore, he seeks time.

9. After having considered the O.A. and annexures thereof and submissions made on behalf of the applicant, prima-facie, it appears that the present Original Application is filed challenging the impugned order of transfer of respondent No. 3, by which the applicant apprehends that he is likely to be transferred from his present post mid-term without following the due procedure of law. It is not disputed that the State Government has banned the general transfers till 30.06.2022 allowing transfers only under special reasons with the approval of the Hon'ble Chief Minister as per the G.R. dated 27.05.2022 (page No. 35 of the paper book). In view of the same, it is difficult to visualize the situation as regards the issuance of

transfer orders this year. It is prerogative of the Government and the competent authority to take decision in accordance with law regarding effecting

transfers. However, the facts would show that likely vacancy of the post of the applicant is declared by the Government in view of this impugned order of transfer dated 25.07.2022 (Annexure A-2). In view of the same, apprehension of the applicant about mid-term transfer without taking recourse to Section 4 (4) (ii) of the Transfer Act, 2005 cannot be said to be totally misplaced or misconceived. In these circumstances, in my considered opinion, it would be just and proper to mould and grant the interim relief in the form of directions to the respondent Nos. 1 and 2 not to disturb the applicant from his present posting till filing of the affidavit in reply by the respondents. It is ordered accordingly.
