The original Applicant has approached the Tribunal with prayer that he be hold suitable for appointment to post of 'Deputy Collector' as per his eligibility and merit for the post which is advertised on 11.05.2022 and has also challenged the 'Sports Validity Report' of Respondent No.5 in OA 383/2024 dated 05.07.2017 as per GR dated 10.10.2017 and so 'Respondent No.5' in OA 493/2024 is not eligible to claim benefit of 5% reservation in 'Sports Category' for 'Group-A Post' and also seeks direction to Respondent Nos. 2, 3 & 4 to be directed to prepare 'Revised Select List' on the basis of Government Policies.
- 3. In this matter, the Tribunal on 21.03.2024 had directed Respondents to maintain 'Status Quo' and further directed by Order dated 19.04.2024 as follows:-

- "8. We direct Department of Sports to verify the Certificates of Respondent No.5 in both the matters as per rules and GR dated 10.10.2017 which are applicable to the Advertisement.
- 9. We further direct Director of Sports to verify whether sports played by Respondent No.5 were organized by the Competent Organization as per requirement.
- 4. Pursuant to Order dated 19.04.2024, Respondent State directed concerned Authority of Sports to re-verify the 'Sports Certificates' of Applicant and also 'Respondent No.5' (ori. Applicant). The 'Deputy Director, Sports and Youth Services' has reverified and submitted 'Report' and said 'Report' was communicated by 'Deputy Director' Shri Manik Patil by letter dated 09.07.2024 that Sports Certificate dated 05.07.2017 of 'Respondent No.5' (ori. Applicant) is invalidated. The said letter dated 09.07.2024 is placed before us.
- 5. The learned Advocate for Respondent No.5 in OA No.493/2024 has submitted that 'Sports Authority' is required to follow proper procedure of re-verification of 'Sports Certificates' as per GR dated 30.06.2022 and especially, concerned 'Committee' was not constituted to re-verify the validity of 'Sports Certificate' of 'Respondent No.5' in OA No. 493/2024. He raised many objections including non-availability of proper 'Forum' for 'Respondent No.5' in OA No. 493/2024.
- 6. We make it clear that once decision was taken by Respondent Authority in respect of 'Sports Authority' of Applicant and 'Respondent No.5' in OA No.383/2024 & OA No.493/2024, we cannot go into as it is not the issue before us.
- 7. We accept the 'Report' as it is in view of relief prayed by Applicant. The 'Respondent No.5' in OA No.383/2024 and OA No.493/2024 who are aggrieved persons because of this 'Report' may follow other 'Legal Recourse'. However, objection cannot be considered in this matter by us.
- 8. As our Order dated 19.04.2024 is complied with by Respondents by re-verifying the Sports Certificate of Applicant and 'Respondent No.5' in OA No.383/2024 & OA No.493/2024, we direct MPSC to take necessary steps and revise 'Merit List' as well as 'Provisional Select List' as per 'Rules'.
- Interim Relief is vacated.
- 10. Shri S.D. Patil, learned Advocate submits that Order of 'Status Quo' to continue for 'One Week' to enable 'Respondent No.5' in OA No.493/2024 to take further steps.
- 11. In view of above, both OA No.383/2024 & OA No.493/2024 stands disposed off. M.A.No.402/2024 & M.A.403 in OA 383/2024 for 'Intervention' similarly M.A.404/2024 & M.A.405/2024 in OA 493/2024 for 'Vacating Stay' also stands disposed off.
