- Ld. PO on instructions from Shri Yogesh Kute, Section Officer states that letter dated 23.2.2024 from Director, Maharashtra Police Academy (MPA), Nashik was received by the office of DGP on 26.2.2024. Earlier letter dated 22.2.2024 was received from MPA by the office of DGP on 22.2.2024 itself. In the letter dated 22.2.2024 MPA, Nashik has pointed out to DGP that present applicant and other 30 candidates did not join the training and Director, MPA has further requested that 17 out of 31 PSI should be replaced by substituting other candidates from the waiting list. DGP has submitted the report accordingly to the Home Thereafter on 18.4.2024 Department on 26.2.2024. Government informed the office of DGP and recommended the names of 17 candidates against 17. The name of the applicant was included as she should be replaced and one female from Open category Ms. Shaikh Uzma Salim was informed by the State. Thereafter the process of collection of documents verification etc. was carried out by the office of DGP and now said Uzma is instructed to join batch No.126 on 23.12.2024 in place of the applicant.
- 3. Ld. PO pointed out that on 7.2.2024 itself the cause of action arose when the request of the applicant made on 27.1.2024 praying for extention for training was rejected. However, she did not approach the Tribunal earlier.
- 4. Ld. Advocate for the applicant submits that the order of 7.2.2024 was served on the applicant on 15.2.2024. She submits that 17<sup>th</sup>, 18<sup>th</sup>, 19<sup>th</sup> and 24<sup>th</sup> February, 2024 were

holidays. Ld. Advocate for the applicant relied on letter dated 19.2.2024 written to the Director and requested that she be allowed to join. On 23.2.2024 the Director, MPA has sent letter to DGP seeking instructions as to whether the applicant can be admitted in the next training and copy of the said letter was sent to the applicant. There is representation dated 7.3.2024 made by the applicant and it was received by the DGP on 12.3.2024.

- 5. We want the respondents to answer the following queries:
- (i) Why the Director, MPA did not reject the application made by the applicant on 19.2.2024 for allowing her to join the training?
- (ii) Why the Director, MPA sent letter to DGP seeking guidance/advise from DGP whether the applicant can be allowed to join the next batch of training on 23.12.2024 and copy of the said letter was addressed to the applicant?
- (iii) It is to be noted that Director, MPA was aware that only under 3 circumstances the extension can be granted viz. pregnancy, indoor patient and higher examination. No power vests with the DGP or Minister/Government to grant extension.
- (iv) Why DGP did not answer the letter dated 23.2.2024 immediately?
- (v) Why DGP office did not communicate and answer the letter dated 7.3.2024 written by the applicant requesting her to join and extension?
