2. As stated in the application the applicant is presently working as Assistant Commandant (SDRF) SRPF Group-6, Dhule. In the present application the applicant has raised the grievance that respondent No. 3 under the garb of attachment has transferred the applicant from Dhule to SRPF, Group-9 at Amravati claiming to be on administrative grounds. Vide order dated 20.3.2023 and vide order dated 24.3.2023 the applicant is shown to have been relieved from his duties. Learned counsel for the applicant submitted that the applicant was posted at existing post in June, 2022 and his normal tenure for the said post is of two years, but before completing the normal tenure on the said post the applicant has been transferred at Amravati. Learned counsel for the applicant has alleged that the aforesaid order is wholly illegal and unsustainable, as well as, contrary to the provisions of law. Learned counsel

submitted that, respondent No. 3 is not the competent authority for issuing such orders.

3. Learned counsel further submitted that his placement being as a Special Disaster Management, he could not have been transferred or attached as stated in the impugned order at Amravati since such post is available only at Nagpur other than Dhule. Learned counsel submitted that there are certain more reasons for taking exception for the orders which are mentioned by the applicant in paragraph 15 of the application, that his son is in the 12<sup>th</sup> standard and his daughter is prosecuting 2<sup>nd</sup> year law at Dhule. It is further contended that distance between Dhule and Amravati is about 350 kms and for all aforesaid reasons the impugned order is sought to be quashed and set aside.

4. It is further argued that the applicant was promoted to the present post and has been given charge of the equipment required for disaster management worth crores of rupees. Learned counsel for the applicant submitted that since the applicant has not yet handed over physical charge of the equipment in his possession and still holding the charge of the same, the impugned orders can be temporarily stayed till decision of the present O.A.

5. The aforesaid request made on behalf of the applicant is opposed by the learned Chief Presenting Officer. Learned C.P.O. has tendered across the bar communication dated 29.3.2023 along with its annexures received to the office of learned C.P.O. from the Additional Director General of Police, S.R.P.F., Maharashtra State, Mumbai. Learned C.P.O. submitted that preliminary enquiry has been conducted against the applicant into the misconduct alleged against him and since he has been *prima facie* found guilty of the said misconduct, now further enquiry is to be conducted against the applicant and having regard to the past experience the respondents thought it appropriate to keep the applicant away from his posting at Dhule and in the circumstances the applicant has been temporarily directed to remain attached with the Amravati unit. Learned C.P.O. submitted that the respondents will file a detailed affidavit in reply in this regard of the competent officer and has, therefore, sought time to file affidavit in reply. Learned C.P.O submitted that present is not the case, wherein interim relief can be granted in favour of the applicant having regard to the facts brought to the notice of this Tribunal. Learned C.P.O. in the circumstances has prayed for time to file affidavit in reply and only thereafter to consider the O.A., as well as, prayer of the interim relief.

6. After having considered the submissions of the learned counsel appearing for the applicant and the learned Chief Presenting Officer and after having perusal the documents filed on record, it appears to me that in the present matter the detailed reply of the respondents will be necessary even for considering the request for interim relief.

7. It is however, apprehension of the applicant that since he is possessing the charge and custody of the equipment worth crores of rupees, the charge must be properly taken by him or else he will come in trouble or may be brought in trouble if anything is missed. It is the contention of the applicant that such detailed charge report has not been prepared.

8. The respondents though have produced on record document showing that the charge has been taken by the applicant by Shri Manoj Yashwant Mohod, Police Inspector, SDRF, the detail charge report is not produced and nothing has been submitted on behalf of the respondents whether such detailed charge report has been prepared or not. In the aforesaid circumstances, it has become necessary to direct the respondents to prepare a detail charge report of the properties in possession of the applicant in capacity of his posting as Assistant Commandant (SDRF), SRPF, Group-6, Dhule,

so that no such issue arises in future that the applicant did not handover the charge completely. This exercise is to be done as expeditiously as possible and in any case within a week from today and thereafter to relieve the applicant.
