2. It is the case of the applicant that she had
applied for the subject post from the OBC category.
According to the applicant, she fulfills all the criteria
as prescribed in the advertisement. The applicant has
been, however, declared ineligible on the ground that
Non-Creamy Layer Certificate submitted by her is not
of the prescribed date i.e. prior to 2nd September,
2021. Learned Counsel for the applicant submitted
that in the advertisement there was no such
requirement and applicant was only under an
obligation to submit Non-Creamy Layer Certificate at
the time of scrutiny of the documents or as and when
required by the respondents. Learned Counsel further

submitted that even otherwise validity of Non-Creamy Layer Certificate issued in favour of the applicant has to be considered in view of the specific guidelines issued in that regard by the Government. It is further contended that the applicant cannot be blamed for submitting the Non-Creamy Layer Certificate dated 24-09-2021 for one more reason that she had applied for the same on 30-08-2021. For all these reasons, the learned Counsel has prayed for interim relief stating that the interviews are in progress and are also scheduled for tomorrow. Learned Counsel has therefore asked for interim relief as prayed in the O.A.

3. Learned CPO has opposed for granting any such relief stating that candidature of the applicant has been rejected on one more ground that she has become age barred.

4. I have considered the submissions advanced by the learned Counsel appearing for the applicant and the learned CPO for the respondents. I have carefully gone through the advertisement. In the advertisement, nothing more is prescribed than requirement that the

candidate concerned must be possessing the Non-Creamy Layer Certificate. I have gone through the Non-Creamy Layer Certificate also. Applicant seems to have applied for the said certificate on 30-08-2021, as has been contended by the learned Counsel for the applicant. The certificate is issued on 24-09-2021 and as stated in the said certificate, the same shall remain valid till 31-03-2024 from the date on which it is issued. It has to be further stated the Non-Creamy Layer Certificate is issued on the basis of income of the applicant concerned or the parents of the said applicant of the period prior to issuance of the said certificate. By applying the said criteria also only inference which has to be drawn will be that, even in the prior period which covers last date of filing of the application dated 02-09-2021, during which the applicant was certainly falling in the category of Non-Creamy Layer.

5. In the advertisement, it is nowhere mentioned that the Non-Creamy Layer Certificate shall be of the date prior to 02-09-2021. In the circumstances, the condition which was not incorporated in the

advertisement should not have been subsequently imposed by the respondents. After having considered the aforesaid circumstances, there appears *prima facie* case in favour of the applicant.

6. Another reason which has been stated in the rejection letter dated 26-08-2022 that the candidature of the applicant cannot be considered from the Open category for the reason that she has crossed the upper age limit. However, the said aspect will arise only if she is found not eligible in OBC category. As stated hereinabove, *prima facie*, it does not appear so. As has been stated by the learned Counsel for the applicant, the interviews are in progress and tomorrow also some interviews are scheduled. In the circumstances, I deem it appropriate to pass the following order:

ORDER

(i) Respondent no.3 shall call the present applicant for interview either tomorrow or if the interviews continue, thereafter on any suitable date.

(ii) The result in respect of the applicant be kept in sealed cover. The appointments made, if any, for the subject of Biochemistry, shall be subject to outcome of the present O.A.

(iii) Issue notice to the respondents, returnable on 30-09-2022.

(iv) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

(v) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

(vi) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

(vii) The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

2. Perusal of M.A.No.349/2022 would show that the said Misc. Application was the amendment application made by the applicant seeking amendment in the Original Application. That was allowed by order dated 26.08.2022.

3. Today learned Advocate for the applicant filed on record the praecipe seeking to delete the expression "default report" inadvertently mentioned in paragraph No.4 of the order dated 26.08.2022 by which the Misc. Application No.349/2022 for amendment was disposed of. In the said paragraph No.4 it was observed as follows:-

"The applicant also by way of amendment wants to place on record his explanation regarding default report."

4. Perusal of the said Misc. Application as well as the Original Application would show that in the Original Application the applicant contended that the people from certain community made complaint that the applicant during period of his duty at Police Station Chikalhana intercepted vehicles carrying the live stock illegally and therefore that is one of the grounds behind issuing the impugned transfer order. In the amendment application, the applicant has given on record various details of registration of crimes in that regard and therefore, the word expression “default report” came to be mentioned inadvertently.

5. In view of same, the word expression “default report” mentioned in paragraph No.4 is deleted from the sentence of “The applicant also by way of amendment wants to place on record his explanation regarding default report”. The said sentence is reframed as follows:-

The applicant also by way of amendment wants to place on record the details of three crimes registered by him intercepting vehicles carrying the live stock,” which produced grudge against him.
