In view of the submissions made by the learned Advocate for the applicant and the learned Presenting Officer for the respondents, the present O.A. is disposed of with a direction to the respondent no. 2 to take a decision on the representation submitted by the applicant dated 22.7.2020 within a period of four weeks from today and communicate the decision thereof to the applicant in writing. There shall be no order as to costs.
