The applicant has approached the Tribunal by filing the present Original Application seeking quashment of the order dated 9.8.2023, whereby respondent no. 5 has suspended the applicant by invoking the provisions under Rule 4 of the Maharashtra Civil Services (Discipline & Appeal) Rules, 1979. The learned counsel for the applicant submitted that the impugned order is ex facie illegal and unsustainable for more than one reasons. Learned counsel pointed out that the appointing authority for the applicant is the State Government and in such circumstances the respondent no. 5 could not have issued any such order and the impugned order is thus apparently without jurisdiction. Learned counsel further argued that for invoking the provisions under rule 4 and ordering the suspension thereunder the pre-

requirement is that the enquiry either must be going on or must be contemplated. In the present matter neither departmental enquiry is initiated nor it is contemplated. Learned counsel further submitted that the applicant has not yet been paid the subsistence allowance.

3. By reading out the contents of the notice, the learned counsel argued that without giving any opportunity of hearing to the applicant, he is held guilty by the respondent no. 5 and it appears that the order of suspension is issued by way of penalty. Learned counsel submits that on all above grounds the impugned order is apparently unsustainable in the eyes of law. Learned counsel further submitted that though the period around 03 months has passed, the applicant has not been served with any statement of charge or any other document evidencing that the D.E. is contemplated against the applicant. Learned counsel in the circumstances prayed for staying the impugned order while issuing the notice to the respondents.

4. Learned Chief Presenting Officer has opposed for granting any relief. Learned C.P.O. submitted that he will take instructions in the matter. Learned C.P.O. further submitted that since 9.8.2023 when nothing has happened as contended by the applicant, opportunity may be given to the respondents to make the submissions on merit.

5. I have duly considered the submissions made on behalf of the applicant, as well as, the respondents. It apparently appears that the respondent No. 5 has passed the impugned order without having any authority therefor. The applicant has placed on record his order of appointment, which evidences that his appointing authority is the State Government. Insofar as contents of the impugned order, I refrain myself from making any comment on it. However, the said contents apparently reveal that without giving any opportunity of hearing to the applicant, the respondent No. 5 has recorded certain conclusions therein. On reading the impugned order, it is difficult to say that the impugned order has been

passed for pending departmental enquiry or for contemplated departmental enquiry.

6. Though for the aforesaid reasons the impugned order prima facie appears to be unsustainable, since the same has been challenged by the applicant after the period of about 2 ½ months and when nothing adverse has happened except the applicant is under suspension, I deem it appropriate to issue notices of shorter period with directions to the respondents to file their affidavit in reply so that the matter can be considered and decided on the same day. Hence, the following order: -

2. Grievance of the applicant is that he was not called for documents verification in the recruitment for the post of Kotwal. The applicant had applied for the post of Kotwal of Village Thalner, Tq. Shirpur. In the written examination the applicant has received 50 marks. Respondent No. 5, who also had contested for the said post, has received 70 marks and his name has been recommended by the respondents for the said post.

3. The applicant has prayed for setting aside the list published of the recommended candidates on 29.10.2023. The applicant has also prayed for declaring him eligible and qualified to appear for the documents verification. We have gone through the contents of the O.A. The applicant has not made

any allegation in respect of the selection of respondent no. 5 on merits. There is no specific prayer for setting aside or quashment of the selection of respondent no. 5. The applicant has also not made any prayer for his appointment on the post of Kotwal of village Thalner, Tq. Shirpur. As noted hereinabove, it is the only grievance of the applicant that he was not called for documents verification. The learned counsel for the applicant argued that not following the procedure as prescribed in the advertisement is sufficient enough to set aside the list issued by respondent no. 3 on 29.10.2023.

4. After having heard the learned counsel appearing for the applicant and after having gone through the contents of the O.A. and the documents placed on record it is apparently revealed that the applicant has preferred the present O.A. without having any cause of action therefor. It is true that the advertisement contains a clause that after written examination the eligible candidates will be called for documents verification. The learned counsel referred to the procedure as prescribed and

more particularly clauses 1 & 2 thereof. We deem it appropriate to reproduce the said clauses, which read thus :-

२. लेखी परीक्षेअंती पात्र उमेदवारांचे जाहिरातीनुसार आवश्यक पात्रता व ऑनलाईन अर्जात भरलेली माहिती यांच्या आधारे मूळ कागदपत्र पडताळणी करण्याकरिता अंतरिम स्वरूपात यादी संकेत स्थळावर जाहीर करण्यात येईल. ज्या उमेदवारांची जाहिरातीनुसार आवश्यक पात्रता व ऑनलाईन अर्जात भरलेली माहिती, परिक्षा शुल्क, मूळ कागदपत्रांच्या आधारे परीपुर्ण सिद्ध होईल अशाच उमेदवारांचा विचार भरती प्रक्रियेच्या पुढील टप्प्या करिता करण्यात येईल. जाहिरातीत नमूद केलेली सुपुर्ण अर्हता, ऑनलाईन अर्जात भरलेली माहिती व मूळ कागदपत्र तपासणीच्या वेळी सादर केलेली कागदपत्रे यामध्ये तफावत आढळल्यास उमेदवारांची उमेदवारी भरतीच्या कुठल्याही टप्प्यावर रद्द होऊ शकेल अथवा अशा उमेदवारांचे मागीतलेले सामाजिक आरक्षण अथवा प्रक्रिया शुल्क इ. सारख्या सवलती नामंजूर करण्यात येतील याची कृपया नोंद घ्यावी.”

5. The aforesaid clauses cannot be interpreted to mean that every candidate, who has passed the written examination, shall be called for document verification. It is true that in the merit list the name of the applicant is at 2nd place. The candidate at sr.

no. 01 i.e. respondent no. 05 has received 70 marks, whereas the applicant has received 50 marks. The other candidates, who seem to have appeared in the written examination, did not receive the minimum marks and 03 such candidates even did not appear for the written examination. When the applicant is not disputing the marks received by respondent no., 5 and his position at sr. no. 1 in the merit list and when there is no further allegation that the respondent no. 5 is for any other reason not eligible to be appointed as Kotwal of Sajja Thalner, Tq. Shirpur, only because the applicant was not called for documents verification, the selection of respondent no. 5 and his recommendation for appointment cannot be set aside. We see therefore no reason for entertaining the present application for want of any cause of action. Hence, the following order :-

The Original Application is rejected summarily without any order as to costs.
