(C) To direct the respondents no. 4 and 5 to decide the representation of the applicant dated 17.12.2018 and 6.2.2019 as per the rules dated 19.9.2002 framed by the respondent no. 1.

(D) To direct the respondent no. 3 to grant exemption to the applicant after completion 45 years of age as per order passed by this Hon’ble Tribunal in O.A. No. 344/2014 and O.A. No. 709/2015 dated 23.7.2018.”

3. Learned Chief Presenting Officer has submitted that the applicant has already been relieved from the present post of Clerk, Tahsil Office, Navapur by the Tahsildar, Navapur on 27.08.2019 (before noon). He has submitted that since the applicant has already been relieved, no question of granting stay to the impugned order arises, as the impugned order has already been executed. He has submitted that the impugned order has been issued by the respondent No. 3 in view of the provisions of Transfer Act 2005 and there is no illegality in it. 4.
