- 5. However, no appointment orders could be issued to Respondent Nos.3 to 5 in view of stay order passed by this Tribunal in the present O.A.No.181/2020 on 16.06.2020. From above, it is evident that the grievances of the Applicant are redressed fully. Hence, the interim relief order dated 16.06.2020 passed by this Tribunal is vacated.
- 6. Consequently, the Original Application is also disposed of as grievances of the Applicant are redressed fully with no order as to costs.
