During the course of hearing it is submitted by the learned counsel appearing for the applicants that, though the applicants are discharging the same duties as were being discharged by them before filing of the writ petition before the Hon'ble High Court and though the Hon'ble High Court has protected the services of the applicants till decision of the present applications, the respondents have not granted the annual increments to the applicants of the intervening period. Learned counsel for the applicants have, therefore, prayed for directions against the respondents to release the annual

4. Prima-facie, we see no rational in not paying annual increments to the applicants when the applicants are discharging same duties as were being discharged by them in the past from the date of commencement of their service. In the circumstances, *prima facie* there appears no reason for withholding the said annual increments of the applicants. Learned C.P.O. shall impress upon the respondents the aforesaid aspects and to see that the employees concerned are not deprived of the annual increments.
