- 5. It appears that the Government has made all possible efforts to serve charge-sheet to the applicant. Meanwhile the Department issued her reversion order dated 18.10.2022 from the post of Sister Tutor to Staff Nurse. We merely deal with the compliance of Article 311 of the Constitution of India which is requisite for any reversion.
- 6. In view of non-compliance of requisite condition of the Departmental Enquiry, we set aside order dated 18.10.2022 as it is IN violation of Article 311 of the Constitution of India. We make it clear that the Department is free to carry out the D.E. against the Applicant in pursuance of the charge-sheet in accordance with rules.
- 7. We direct the applicant to cooperate in the D.E. which is to be completed forthwith. Applicant is directed to cooperate in the said D.E. which should be completed within a period of four months i.e. on or before 31.03.2023.
- 8. In view that noting remains in the O.A., the same stands disposed of.
