- 2. The applicant has preferred the present Original Application seeking declaration that he is entitled to be continued in the service on the post of Medical Officer pursuant to the Maharashtra Civil Services (Pension) (Amendment) Rules, 2022 notified on 23.2.2022 till he completes the age of 60 years.
- 3. Learned counsel for the applicant submitted that the applicant apprehends that he will be retired today as he has attained the age of 58 years in this month. Learned counsel also pointed out that in the salary slip also his date of retirement is mentioned as 30.11.2023. Learned counsel submitted that in O.A. No. 623/2023 with connected other O.As. though this Tribunal at principal seat at Mumbai has taken a view that the Medical Officer may not be

entitled for the benefit of enhanced age of retirement, in the Writ Petition No. 11453/2023 with other connected Writ Petitions filed against the said order of the Tribunal, the Hon'ble Bombay High Court has passed interim order, thereby directing the respondents to continue the said petitioners till they attain the age of 60 years, of course, by providing certain riders.

4. The facts in the instant matter are identical to the facts, which existed in the matters before the Hon'ble High Court, wherein some interim orders are passed by the Hon'ble High Court. In view of the said orders, we are inclined to pass the following order:-

#### ORDER

- (i) Issue notice to the respondents, returnable on 10.1.2024.
- (ii) Pending the hearing and final disposal of the present Original Application, the respondents shall continue the present applicant in service till he attains the age of 60 years.
- (iii) We make it clear that the continuation of the present applicant till he attains the age of 60 years will be subject to the outcome of the present O.A. The question of the Respondents' power, in case the applicant fails in his

challenge, to pass necessary orders in respect of recovery/adjustment of the pay/wages paid to him for the services rendered under the interim order, is kept open.

- (iv) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- (v) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- (vi) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
- (vii) The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date.

2. It is the case of the applicant that because of grave illness, he was not on duty. It is the further contention of the applicant that subsequently in pursuance of the order passed by his superior, he reported for duty, but could not proceed to Mumbai since there was no fitness certificate in his favour. Learned counsel for the applicant submitted that insofar as the order of suspension is concerned, the applicant is challenging the said order on more than one grounds, however, presently the applicant is claiming interim relief, seeking direction against the respondents to allow the applicant to appear for the Limited Departmental Competitive Examination to be held by the M.P.S.C. for promotion to the post of P.S.I.

- 3. The request made by the applicant is opposed by the learned Presenting Officer by submitting that the permission to appear for Limited Departmental Competitive Examination for promotion to the post of P.S.I. has been duly refused to the applicant having regard to the conduct of the applicant, which is apparently not befitting to a Police personnel. Learned P.O., therefore, opposed for granting any interim relief in favour of the applicant.
- 4. We have considered the submissions advanced on behalf of the applicant, as well as, the respondent authorities. We have gone through documents placed on record. From the record it appears that permission was already granted to the applicant to for Limited Departmental Competitive appear Examination for promotion to the post of PSI. Vide the impugned order the said permission has been cancelled. From the documents it is evident that before cancelling the said permission the applicant has not been given any opportunity to show cause why the said permission shall not be cancelled. Insofar as absence of the applicant from duty is concerned, the Department may take appropriate

action against the applicant, however, if permission was earlier granted to the applicant for appearing to the examination, before cancelling the said permission it was necessary to issue show cause notice to the applicant. Hence, we deem it appropriate to pass the following order:-

## ORDER

- (1) Subject to the office objection in regard to not availing the alternate efficacious remedy of filing departmental appeal, issue notice to the respondents, returnable on 6.12.2023.
- (2) The impugned order, insofar as it relates to cancellation of permission to the applicant to appear for Limited Departmental Competitive Examination (Preliminary) for promotion to the post of PSI, shall stand stayed till the next date.
- (3) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- (3) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

- 2. The applicant has applied for the post of Kotwal for Saja Parola, Tq. Paroal, District Jalgaon in pursuance of the advertisement published by respondent No. 3 on 14.07.2023. The applicant appeared for the written examination on 13.08.2023 and scored 40 marks and got 2<sup>nd</sup> rank in the merit list. Respondent No. 5 secured 62 marks and got first place in the merit list.
- 3. The candidature of respondent No. 5 was objected to by the present applicant on the ground that respondent No. 5 is not the resident of Saja Parola and she is resident of village Mhasve Shivar, which comes in different Saja. The applicant in support of her contentions placed evidence available with her to show that respondent No. 5 was not resident of Saja Parola

and thus was not entitled for appointment on the post of Kotwal of the said Saja.

- 4. The enquiry was conducted in the matter and report was submitted to the learned Additional Collector, Jalgaon. The learned Additional Collector after having gone through the documents submitted by the parties and the report submitted by its subordinate authority held respondent No. 5 to be resident of Saja Parola and rejected objection raised by the present applicant and vide his order dated 07.11.2023 directed the Tahsildar, Paroal to issue order of appointment in favour of respondent No. 5. It is the contention of the applicant that the aforesaid order was received to the applicant on 21.11.2023 and thereafter within a week's he has approached this Tribunal.
- 5. Learned counsel appearing for the applicant invited our attention to the terms and conditions as are incorporated in the advertisement published on 14.07.2023. In the terms and conditions it has been mentioned that, the candidate, who has applied for a particular Saja, must be resident of the said Saja and he must produce on record the evidence in that regard and such evidence must be available with him on the date of making application. Learned counsel pointed

out Clause Nos. 2, 7 and 8, which stipulate that the candidate must be local resident of the village for which he has made an application. Clause 8 further clarifies that since candidate can only be a permanent resident of only one Saja, he cannot make application in more than one Saja for the post of Kotwal. Learned counsel submitted that the conditions, which are incorporated in the advertisement, unambiguously demonstrate that the person must be resident of the Saja, in which appointment is to be made on the post of Kotwal.

6. Learned counsel appearing for the applicant submitted that in the enquiry, which was conducted by the Tahsildar, wherein the Circle Officer submitted his report, it has come on record that few months before the date on which the team visited the address, which was given by respondent No. 5, the house was taken on rent by respondent No. 5. Report further reveals that other relatives of respondent No. 5 are residing at village Mhasve. It is further stated that the fresh application has been made recently by the husband of respondent No. 5 for obtaining ration card. According to the applicant, that was submitted after the date of filing application. Learned counsel for the applicant submitted that the learned Additional Collector

Tahsildar as about inspection on the spot has erroneously held the applicant to be resident of Saja Parola. Learned counsel submitted that yet the order of appointment has not been issued in favour of respondent No. 5. Learned counsel submitted that considering the evidence on record which *prima facie* reveals that respondent No. 5 is not resident of Saja Parola, the respondents be restrained from issuing appointment order in favour of respondent No. 5. Learned counsel submitted that since the applicant is on the second postion and she is resident of village Saja Parola, in fact, she is the candidate who fulfills all the criterias and she is liable to be appointed on the said post.

7. Learned Presenting Officer has opposed for granting any relief as has been prayed on behalf of the applicant. Learned P.O. submitted that the Additional Collector has considered the evidence, which was placed before him and has passed reasoned order, thereby holding respondent No. 5 to be resident of Saja Parola. Learned Presenting Officer further submitted that even otherwise respondent No. 5 is holding meritorious position. It is pointed out that when respondent No. 5 has earned 62 marks, the present

applicant has secured only 40 marks and that is the also reason that the decision has been taken to appoint respondent No. 5 on the post of Kotwal.

- 8. We have duly considered the submissions made on behalf of the applicant, as well as, respondent authorities. We have also gone through the terms and conditions containing in the advertisement. For deciding the controversy, which has arisen in the present matter, at this juncture the relevant aspect to be considered would be how to interpret the term 'resident of Saja'.
- 9. From the terms and conditions prescribed in the advertisement it is apparent that the expectation is that the candidate who is seeking appointment on the post of Kotwal must be a resident of the said Saja. In Marathi, word used is "स्थानिक रहिवाशी". The facts on record *prima facie* reveal that respondent No. 5 has started residing in Saja Parola by taking a house on rent since past two months and prior to that she was residing at Saja Mahsave. The material on record further reveals that in the spot inspection and enquiry carried out by the Circle Officer it was revealed that respondent No. 5 is not स्थानिक रहिवाशी of Saja Parola. We, therefore, see *prima facie* substance in the objection raised by the applicant that respondent No. 5 cannot

be said to be resident (स्थानिक रहिवाशी) of Saja Parola. It appears that the Additional Collector has not appropriately considered the report submitted to him by his subordinate officers while passing the impugned order. The applicant has thus made out a *prima facie* case for grant of interim relief as claimed by her. In the circumstances, we are inclined to pass the following order: -

## ORDER

- (i) Issue notice to respondents, returnable on 21.12.2023. Till then no effect shall be given to the order dated 7.11.2023 passed by respondent No. 2.
- (ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- (iii) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- (iv) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

- 2. The present applicant had submitted an application seeking voluntary retirement. It came to be rejected vide communication dated 26.12.2019 on the ground that the applicant is owing certain amounts which he has obtained from the Government. However, it is further stated that after the said amount is recovered or deposited by the applicant the office concerned shall resubmit the proposal of his voluntary retirement. It is the contention of the applicant that he had deposited the amount prior to the date of notice.
- 3. In a query made by us whether after receiving the order dated 26.12.2019 the fact that the entire amount has been deposited was communicated by the applicant to the said authority, learned counsel submitted that no such correspondence was made. It appears to us that instead of filing the present O.A. it

would have been better and in the interest of the applicant that he approaches the authority concerned bringing it to its notice that he has already deposited the amount and his proposal, therefore, liable to be reconsidered. In the circumstances, it appears to us that the present Original Application can be disposed of with the following order: -

# ORDER

- (i) The applicant may submit representation in view of the order passed on 26.12.2019 brining to the notice of the authorities that he has deposited the entire amount with payment receipts thereof or any other evidence which the applicant is possessing in support thereof. Such representation shall be made by the applicant within two weeks from the date of this order.
- (ii) After receipt of the representation from the applicant, the authorities concerned shall take the appropriate decision on the same within four weeks thereafter and communicate the same to the applicant in writing.
- (iii) Needless to state that even thereafter the dispute subsists, it would be open for the applicant to approach this Tribunal.
