2. The applicant is working as Assistant Professor on ad-hoc basis in Community Medicine (P.S.M.) Department at Dr. Shankarrao Chavan Govt. Medical College, Nanded, District Nanded. The applicant has applied for regular appointment on the post of Assistant Professor for the said subject. It is the grievance of the applicant that the eligibility criteria to the effect that the candidate concerned must have experience of working on the post of Senior Resident cannot be applied insofar as appointment to the post of Assistant Professor in the subject of Community Medicine is concerned. Learned counsel pointed out that the Community Medicine falls in the category of Preclinical & Paraclinical for which the experience of working on the Senior Resident many not be compulsory. Learned counsel pointed out that in the similar set of facts and circumstances this Tribunal, as well as, Nagpur Bench of this Tribunal have passed interim order thereby directing the Maharashtra Public

Service Commission to conduct the interviews of all such candidates, subject to outcome of the respective petitions.

3. Learned Presenting Officer has sought time for fiing affidavit in reply and expressed his inability to make authentic submissions for want of instructions.

4. Learned counsel for the applicant has pointed out that the interviews are scheduled in the next week and, as such, there is urgency and the interim relief needs to be granted in favour of the applicant as has been granted in the similar matters.

5. After having considered the submissions advanced by the learned Counsel for the applicants and the learned PO and after having gone through the documents filed on record, I am convinced that *prima facie* case is made out by the applicant for grant of interim relief in his favour. Moreover, in the cases of similarly situated candidates, this Tribunal, as well as, Nagpur Bench of this Tribunal had already granted such interim reliefs, I am therefore, inclined to pass the following order: -
