(PER: JUSTICE SHRI P. R. BORA)

In view of the fact that no material has been brought on record by the respective respondents in all these O.As. to satisfy that it was not reasonably practicable to hold enquiries against the respective applicants before ordering dismissal of these applicants from the police services in terms of proviso (b) appended to clause (2) of Article 311 of the Constitution of India, in our opinion, the impugned orders cannot be sustained and deserve to be set aside. We accordingly set aside the orders impugned in all these O.As. The respondents are directed to reinstate the applicants in service within one month from the date of uploading of this order on the official website of the Tribunal. However, in view of the discussion made by us in the body of this order it

would be open to the respondents to initiate departmental enquiries against the applicants, if they so desire. If so decided, such enquiries must be initiated as expeditiously as possible, and not later than 2 months from the date of uploading of this order on the official website of the Tribunal and shall be completed possibly within 6 months from their commencement. The applicants shall ensure that the enquiry proceedings are not delayed or protracted at their instance. Payment of backwages shall abide by the result of the said enquiries.

If the Disciplinary Authority forms an opinion that enquiry against the applicant is not likely to be conducted fairly by keeping the applicant on the same post from which he was dismissed, it would be open for the Disciplinary Authority to take necessary measures, like assigning any other work to the applicant or to suitably transfer him to some other branch or take other similar measures during the period of enquiry.

In so far as the O.A.No.21/2020 is concerned, since the applicant has expired during the pendency of the O.A., in the said case, there may not be a question of reinstating the applicant or initiation of any departmental enquiry against him. However, in view of the fact that his order of

dismissal has been set aside, the said applicant shall be deemed to be in service at the time of his death and his legal heirs may claim the benefits, payable to the Government servant dying while in service.

All the above O.As., thus, stand allowed in the aforesaid terms, however, without any order as to costs.

2. It is the contention of the applicants that they are working as Medical Officers, Group-A (Class-II) at Government Medical College, Latur since last about 7 years. It is the further contention of the applicants that they have time and again made representations for regularization of their services, however, the representations have not been decided by the concerned authorities.

3. The learned counsel for the applicants submitted that without considering the representations of the applicants and similarly situated Medical Officers for regularizing their services, respondent No. 3 has now issued an advertisement on 22.7.2022 for filling in the posts of Assistant Professors in the Government Medical Colleges in the State. Total 427 posts are advertised. The learned counsel submitted that respondent No. 3 instead of issuing an advertisement

must have considered the representations submitted by the applicants and similarly situated others for regularization of their services. Learned counsel submitted that the applicants now cannot be asked to undergo the selection process for the reason that already they have ample experience of working on the post of Assistant Professor. In the circumstances the learned counsel has sought an order against the respondents restraining them from carrying out the selection process in pursuance of the advertisement dated 22.7.2022 till decision of the present Original Application.

4. Learned counsel submitted that in the similar set of facts and for the similar relief some of the similarly situated candidates have approached the Principal Bench of this Tribunal at Mumbai and the Principal Bench has passed an order in favour of the said applicants. The learned counsel tendered across the bar the order passed by the Principal Bench on 4.8.2022 in the O.A. No. 770/2022. We have through the said order. Learned C.P.O. has opposed for granting such interim relief. He has sought time for filing affidavit in reply.

5. After having considered the submissions advanced by the learned counsel and after having gone through the order dated 4.8.2022 passed by the Principal Bench in O.A. No. 770/2022 it appears to us that *prima facie* case is made out by the applicants. In

the circumstances we deem it appropriate to pass the following order: -

ORDER

1. Issue notice to respondents, returnable on 25.11.2022.
2. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
3. Applicants are authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
4. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
5. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.
- 6. In view of the fact that the applicants have been working as Medical Officers since last few years on temporary basis, the Respondents shall continue their services on temporary basis till the subject posts are regularly filled up.**
