In the present O.A., the Applicant has challenged the impugned order dated 24.07.2019 issued exercising the powers under Section 4(4)(ii) and 4(5) of Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 (hereinafter referred to as 'Act 2005). 3. Learned Counsel for the Applicant contends that the impugned order is mid-term and mid-tenure transfer and secondly it is in contravention of Divisional Cadre Structure and Divisional Cadre Allotment for direct appointment by nomination to the post of Group A and Group B (Gazetted and Non-Gazetted) of the Government of Maharashtra Rules, 2015. He has also pointed out Rule No.8 which provides for minimum six years tenure in Division for Group-A employee as the Applicant happens to be. 4. Whereas, learned C.P.O. submitted that the decision of transfer of the Applicant has been taken from the point of 'administrative exigency' to fill in the post with the approval of CSB as well as with the approval of Hon'ble Chief Minister. She has also produced the file for perusal. 5. The Applicant is serving as Deputy Commissioner at Panvel Municipal Corporation and by impugned transfer order, he has been transferred as Chief Officer, Chalisgaon, Dist. Jalgaon in place of Shri Manorkar. By another order dated 24.07.2019 Shri Manorkar who is serving at Chalisgaon has been transferred to Pandharpur. Thus, it is not the case that post of Chief Officer was vacant. Suffice to say, the Applicant has been transferred consequent to transfer of Shri Manorkar. 6. True, the transfer is an incident of service and executive has prerogative in this behalf and normally the Tribunal should not interfere in the transfer unless it is in contravention of express Rules in this behalf. |

| | <p>7. The Applicant is shown transferred in caption 'administrative exigency' which is not clarified as to what constitute 'administrative exigency' for mid-term and mid-tenure transfer. Secondly and the most importantly, the transfer is in contravention of Rule 8 of Cadre Allotment Rules, 2015 which provides for minimum six years tenure of the employee falling in Group 'A' for one division. In note produced by C.P.O. no justification is forthcoming for breach of Cadre Allotment Rules, 2015.</p> <p>8. I am, therefore, satisfied that prima-facie the impugned transfer order is not in consonance with law and deserves to be stayed.</p> <p>9. In view of above, Interim relief is granted in terms of prayer clause 10(a).</p> <p>10. Issue notice before admission returnable on 28.08.2019.</p> <p>11. 
