Learned Advocate for Applicant then refersagain to the directions of Revenue & Forest Department on 10.07.2024 to state that 'Transfer Order' of Applicant came to be issued by 'Additional Chief Conservator Forest (Administration Subordinate Cadre) Nagpur' on 24.07.2024 as per provisions of 'Section 4(4)(ii)' and 'Section 4(5)' of 'The Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005' based on recommendation made earlier by 'CSB' under 'Chief Conservator Forests (Territorial), Thane'.
- 4. Learned Advocate for Applicant thereupon states that 'Chief Conservator of Forest (Territorial) Thane', has thereupon issued 'Office Order' on 29.07.2024 to effect to transfer of Applicant from the post of 'Forester' at Badlapur in 'Badlapur Forest Range' of 'Thane Forest Division' to the post of 'Forester' at

- transfer of Applicant from post of 'Forester' at Badlapur in 'Badlapur Forest Range' of 'Thane Forest Division' could not have been done on request of Applicant; as Applicant had been posted there on 09.08.2021 and was yet to complete 'Normal Tenure' of 3 Years. Further it is necessary to contend that Revenue and Forest Department GR dated 11.01.2018 does not validly designate 'Competent Transferring Authority' and next 'Superior Transferring Authority' of 'Forest Department' as it cannot be substitute for 'Notification' required to be issued under 'Section 7' of 'The Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005'.
- 6. Learned Advocate for Applicant then draws attention to provisions of GAD GR dated 11.02.2015 which relates to 'Mid Term' and 'Mid Tenure' transfers of 'Government Servants' and specifically draws attention to contents of 'Para 5' which require 'Peoples Representatives' like 'MLA's/MLC's to send their recommendation letter alongwith attached representation made by 'Government Servants'.
- 7. Learned Advocate for Applicant further amplifies the present context Mid Term' & 'Mid Tenure' transfer of Applicant by referring to the Judgment passed by Hon'ble Bombay High Court, in Writ Petition No. 8987/2018 dated 21.12.2018 which extensively dealt with the issue of 'Political Influence' in matters relating to transfers of 'Government Servants' under 'The Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005'.
- 8. Learned PO seeks time to obtain information about the issues raised by learned Advocate for Applicant.
- 9. The transfer of Applicant from post of 'Forester' at Badlapur in 'Badlapur Forest Division' of 'Thane Forest Division' to post 'Forester' at Kola in 'Murbad Forest Range' of 'Thane Forest Division' appears to have been done 'prima-facie' based on the request made by 'MLA' from Nashik District. Therefore the validity of

'Transfer Order' issued by Additional 'ACCF' (Administration & Subordinate Cadre), Maharashtra State Nagpur, on 24.07.2027 and subsequent Office Order issued by 'Chief Conservator of Forest (Territorial) Thane' on 29.07.2024 will have to be tested not only on facts and circumstances but also for validation under provisions of law which span across 'Section 3(1)', 'Section 4(4)(ii)' and 'Section 4(5)' of Maharashtra Transfer Act 2005. Hence till such time as information is received by learned PO, it is necessary to give directions to maintain 'Status Quo' in respect of 'Transfer Orders' issued by 'Additional Chief Conservator Forest (Administration Subordinate Cadre) Nagpur' 24.07.2024 of both Applicant and Respondent No.3.

Hence, it is quite evident that Applicant who was serving on post of 'Clinical Psychologist' on 'Temporary Basis' for terms of '11 Months' does not belong to cadres of either (i) 'Maharashtra Medical and Health Services: Class - II' or (ii) 'Maharashtra Medical and Health Services Class III'. Further the Applicant though serving on 'Temporary Basis' for period of '11 Months' as 'Clinical Psychologist' in 'Yerwada Central Jail', the post which has been categorized as 'Class-I' and

- Learned Counsel has submitted Applicants Mr. N.B. Sanap (O.A.No.910/2024) and Mr. H.S. Rewaskar (O.A.No.911/2024) have applied for the post of Deputy Director (Group-A) and Assistant Director (Group-B) respectively in the office of Industry, Safety and Health Department. Applicants pray to quash and set aside the impugned order dated 19.07.2024 and direct the Respondent No.1 to issue appointment order of the applicants for the respective posts in the light of the Recruitment Rule 2009, and the Advertisement dated 25.02.2022. Learned Counsel has submitted that similar challenge was made before the Aurangabad Bench in O.A.No.576/2024 and it was directed to keep one post vacant for the applicant in the said case. Learned Counsel seeks similar relief in the present O.A.
- 3. Learned Counsel has submitted that Applicant in O.A.No.910/2024 has worked as Sectional Engineer, Regional Workshop, Peth Road, Nashik during the period from 01.08.2016 to 31.01.2022 and Applicant in O.A.No.911/2024 has worked as Junior Engineer in Mechanical Sub Division, Ghulewadi, Sangameer during the period from 01.04.2013 to 31.07.2016 and Sectional Engineer in Regional Workshop Sub Division, Nashik during the period from 01.08.2016 to 31.01.2022. Hence, Applicant has a composite period of nine years as experience. Learned Counsel has pointed out the definition of 'Factory' as per Section 2(m) of the Factories Act No.63 of 1948.

Tribunal's orders

- 4. The Applicant, Mr. Sanap's experience of working during the period from 01.08.2016 to 31.01.2022 and Applicant, Mr. Rewaskar's experience of working during the period from 01.04.2013 to 31.07.2016 and thereafter from 01.08.2016 to 31.01.2022 is to be counted as valid experience.
- 5. Learned Counsel has submitted that selection process was completed on 25.09.2023 and Respondent issued G.R. on 12.10.2023. In the said G.R. the Recruitment Rules, 2009 was changed which is not as per law. He has also pointed out paragraph 6 of letter dated 26.04.2024 addressed to the Superintending Engineer, Mechanical Division, Nashik wherein it is informed that the experience of the applicant in O.A.No.911/2024 is of 8 years and 10 months and it is consistent with the Recruitment Rules for the post for which he is selected.
- 6. Today, Mr. K.P. Patil, Under Secretary from the office of Respondent No.1, Labour Department is present. Learned P.O. has submitted that the Applicants are having the experience of working in 'Workshop' whereas the experience of working in 'Factory' is required as per rules.
- 7. In view of above, we would like to make Water Resource Department, suo moto as party Respondent in O.As in the array of Respondents. Learned Counsel is directed to make necessary amendment and serve the copy to the added Respondent, Water Resource Department.
- 8. We direct the concern Department not to issue any appointment order till we consider the case of the Applicants for interim relief. Respondent-Department is directed to maintain status quo as on today.
- 9. Adjourned to 13.08.2024.
