- 2. The present O.A. is filed to challenge the order dated 17.05.2018, thereby he was promoted from the post of Unskilled Craftsman to the post of Semiskill Craftsman and was posted at Buldhana. According to Applicant, the proposed place of promotion and posting Buldhana given to him is not convenient on the ground that his wife is suffering from Psychological disorder and under the treatment of Doctor at Ulhasnagar. As such, the posting at Buldhana is not convenient to him. On this ground, he filed the present application for cancellation of order dated 17.05.2018 with direction to Respondent No.3 to transfer and promote him at his convenient place nereby Ulhasnagar.
- 3. Today, the Respondent No.3 has filed Affidavit-in-reply. The same is taken on record.
- Basically, the application itself is 4. maintainable in its form. Surprisingly, the Applicant has sought the relief of cancellation of order dated 17.05.2018 whereby he was promoted contending that it is in violation of provisions of Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005. In fact, the order dated 17.05.2018 cannot be termed as transfer order, as it is promotion order. It may be noted that Section 4(4) proviso of Act, 2005 makes it clear that the transfer may be made any time in the year, if necessitated on account of retirement, vacancy. promotion, resignation, reversion, reinstatement, etc. Whereas, as per Section 2(i) of Act 2005, transfer means posting of a Government servant from one post, office or department to

another post, office or department. Suffice to say, the petition itself is not maintainable.

- 5. At this stage, the learned Advocate for the Applicant submitted that she wants to withdraw the application and she does not want to forego the promotion. Her client wants to join his place of posting given on promotion and to file representation before Department for convenient place.
- 6. In view of the statement made by the learned Advocate for the Applicant as well as the statement made by the Applicant in person that he accept the promotion, this application is disposed of.
- 7. Permission to withdraw the petition is granted. No order as to costs.


