2. The applicants have filed the present application seeking review of the order passed by this Tribunal on 11.1.2022 in O.A. No. 384/2019. Shri Avinash Deshmukh, learned counsel holding for Shri M.B. Kolpe, learned counsel for the applicants submitted that the reason recorded by the Tribunal in para 6 of the order under review runs contrary to the “doctrine of prospective overruling” introduced by the Hon’ble Apex Court with the view to avoid reopening of the settled issues. The learned counsel further submitted that the order passed in O.A. No. 437/2012 on 2.4.2014 was passed by the Tribunal in view of the law holding the field at that point of time and the decision so rendered attained the finality as it was not challenged before any higher forum. Learned counsel submitted that in the circumstances the benefits flowing therefrom cannot be

denied on the basis of a subsequent judgment. Learned counsel further submitted that the Tribunal while passing the order under review has also considered the fact that the order passed in O.A. No. 437/2012 since has not been challenged further has attained the finality. Learned counsel further submitted that the further observations made by the Tribunal, however, apparently run contrary to the “doctrine of prospective overruling”, wherein the court has observed that in view of the law laid down subsequent to the passing of order in O.A. No. 437/2012 the applicants cannot be held entitled for the benefit arising out of the decision rendered in O.A. No. 437/2012. Learned counsel relied upon the judgment of the Hon’ble Apex Court in the case of **Baburam VS. C.C.Jacob, 1999 AIR (SCW) 1447** to support his contention.

3. Learned counsel for the applicants pointed out that non-joining of the parties likely to be affected is another ground, which has resulted in dismissal of O.A. No. 384/2019. The learned counsel submitted that it is a curable defect and if the review application is allowed and the original application is restored for hearing afresh, if required, the affected parties can be impleaded with permission of the Tribunal.

4. Learned Chief Presenting Officer submitted that there is no apparent error in the impugned order/judgment. Learned C.P.O. submitted that the Tribunal has taken into account the law existing on the day the matter was decided and since the judgment delivered by the Hon'ble Supreme Court becomes applicable to all pending matters, according to him, no mistake can be said to have occurred in making observations by this Tribunal that the position of law was not settled earlier and subsequently, the law came to be crystalized. He, therefore, prayed for rejecting the application.

5. We have duly considered the submission made on behalf of the parties. The Hon'ble Apex Court in the case of **Baburam VS. C.C.Jacob** (cited supra) has explained that, "the prospective declaration of law is a devise innovated by the apex court to avoid reopening of settled issues and to prevent multiplicity of proceedings". Hon'ble Supreme Court has further observed that, "by the very object of prospective declaration of law, it is deemed that all actions taken contrary to the declaration of law prior to its date of declaration are validated". The Hon'ble Supreme Court further observed that, "the subordinate forums which are legally bound to apply the declaration of law made by this Court are also duty-

bound to apply such dictum to cases which would arise in future only and in matters where decisions opposed to the said principle have been taken prior to such declaration of law cannot be interfered with on the basis of such declaration of law”.

6. In view of the law laid down by the Hon’ble Apex Court in the case of **Baburam VS. C.C.Jacob** (cited supra) we are convinced that the observations made in para 6 of the order under review, which are specifically brought to our notice, run contrary to the “doctrine of prospective overruling”. It is the apparent error occurred while passing the order under review. The review application, therefore, deserves to be allowed. Hence, the following order: -

ORDER

(i) The order passed by this Tribunal in O.A. No. 384/2019 on 11.1.2022 is hereby recalled and the matter is restored to its file for hearing afresh.

(ii) The review application stands allowed in the aforesaid term. There shall be no order as to costs.
