2. The order of transfer dated 29.4.2022, whereby the applicant has been transferred from Paithan to Talegaon, Tq. Phulambri, Dist. Aurangabad, has been challenged by the applicant. Though several grounds are raised in exception to the said transfer order, after having gone through the affidavit in reply filed on behalf of the respondents and the documents filed by the respondents in support of the contentions raised in their affidavit in reply I see no case in favour of the applicant, so as to cause any indulgence in the order of transfer. transfer has been effected on certain serious allegations against the applicant. I may not indulge in making any more discussion as about veracity of the allegation so raised against the applicant, however, there appears prima facie substance in the complaint filed against the applicant. Certain enquiries are also initiated in that regard.

- 3. Learned counsel for the applicant has tendered across the bar copies of communication made by the applicant with the Sub-Divisional Officer, Paithan-Phulambri Division, Headquarter Aurangabad and also placed on record one affidavit sworn in by Irshad Mohammed Sharif Shaikh R/o. Paithan, Tq. Paithan, Dist. Aurangabad. The documents are taken on record.
- 4. Learned counsel for the applicant submitted that Irshad Shaikh, on whose complaint the further actions were initiated against the applicant, himself has sworn in an affidavit that he had not made any complaint against the applicant and further that so-called complaint does not bear his signature. Learned counsel submitted that in view of the affidavit sworn in by said Irshad Mohammed Sharif Shaikh, it has come on record that somebody has made a false complaint against the applicant in the name of said Irshad Shaikh. Learned counsel, therefore, submitted that the order of transfer of the applicant deserves to be quashed and set aside.
- 5. I am however, not convinced with the submission so made. For a moment even if it is accepted that Irshad Shaikh did not make any complaint against the applicant even then the malpractices indulged into by the applicant, which are revealed to the higher Revenue

Officers during the course of the enquiry cannot be ignored. The documents on record clearly reveal the role of the applicant in illegal excavation of sand.

- 6. In the circumstances, the O.A. deserves to be dismissed and is accordingly dismissed.
- 7. During the course of the arguments it has been pointed out by the learned counsel appearing for the applicant that the applicant is suffering from Cancer and he is undergoing treatment at Aurangabad. The medical papers are filed on record, which support the contentions of the applicant. On the said ground it is the contention of the learned counsel appearing for the applicant that the transfer needs to be cancelled and the applicant requires to be retained at Paithan. already held that no case is made out for causing any indulgence in the impugned transfer order. However, on medical grounds the applicant may again make a representation to the competent authority by annexing all relevant documents in support of his contention and make request for transfer at some other place which may be suitable for him to take treatment. representation is made by the applicant, the respondents
