- 2. The applicant has become entitled for his promotion to the post of Range Forest Officer. It is the contention of the applicant that in the meeting of Departmental Promotion Committee (DPC), the decision in regard to his promotion has been kept in sealed envelope for the reason that he is undergoing punishment imposed upon him of withholding 2 increments for 2 years without future effect. Learned Counsel submits that the period of punishment is going to expire on 30-06-2022.
- 3. It is the further contention of the learned Counsel that since the right has accrued in favour of the applicant to opt for a revenue zone, result needs to be declared

and the applicant needs to be permitted to opt for Revenue Zone of his choice. Learned Counsel submitted that the said process is likely to be completed soon and if he is not permitted give his preference for a particular Revenue Division, his right of choosing the said Division is likely to be frustrated. In the circumstances, the applicant has prayed direction against the respondent to open the sealed cover and to include the name of the present applicant in the list of eligible candidates to be promoted to the post of Range Forest Officer. Learned Counsel submits that the applicant is aware that the promotion order is not likely to be issued till he completes the period of punishment, however, if his name is included in the list of eligible candidates for promotion, he will be able to give his preference for a Revenue Division of his choice.

4. Learned P.O. has sought time for filing the detailed reply to the O.A. Learned P.O. submits that until the period of punishment is expired, sealed cover cannot be opened.

- 5. We have considered the submissions advanced on behalf of the learned Counsel for the applicant as well as the learned P.O. for the respondents. Learned Counsel for the applicant is relying on the judgment of this Tribunal in O.A.No.886/2017. Learned Counsel has also invited our attention to the relevant G.R.
- 6. It is not in dispute that the period of punishment imposed upon the present applicant will expire on 30-06-2022. It is further not in dispute that DPC has considered the case of the present applicant but has kept the result in the sealed envelope in view of the fact that period of punishment is not yet expired.
- 7. In O.A.No.886/2017, this Tribunal has held that the decision of withholding promotion cannot be upheld only on the count that candidate concerned is undergoing punishment. Referring to the law laid down by the Hon'ble Supreme Court, Tribunal has further held that when the DPC has found the candidate eligible for promotion, the

said candidate cannot be deprived of the said right because of the fact that he is undergoing the period of punishment.

- 8. In the circumstances, while issuing notice to the respondents, we direct the respondents to open the sealed cover and based on the decision taken by the DPC, include the name of the present applicant in the list of eligible candidates for promotion, if DPC has recorded such opinion and held the present applicant eligible for promotion.
- 9. Issue notice to the respondents, returnable on 02-5-2022.
