- 3. The applicants are possessing the educational qualification of Bachelor in Production Engineering. The respondent No. 3 i.e. the M.P.S.C. has issued advertisement dated 24.02.2023 (Annexure 'A-2') for filling up various posts including the post of Assistant Regional Transport Officer (ARTO). Clause No. 6.4.1 of the said advertisement prescribes educational qualification for the said post as Mechanical Engineering and Automobile According to the applicants the Engineering. Bachelor degree in Production Engineering held by them is equivalent to the said requisite educational

qualification to Mechanical Engineering and Automobile Engineering.

- 4. As per the said advertisement, the dates for making online application as per clause No. 9.5.6 was between 2<sup>nd</sup> March, 2023 to 22<sup>nd</sup> March, 2023. The respondent No.3 i.e. the M.P.S.C. however, by subsequent corrigendum dated 10.03.2023 extended the date upto 3<sup>rd</sup> April, 2023.
- 5. The applicants before prescribed date of 22<sup>nd</sup> March, 2023 attempted to fill up online application. However, their attempts were failed and the applications were rejected on the ground that they are not eligible for the post and did not match educational qualification prescribed. The applicants made representations to the respondent No.3 i.e. the M.P.S.C. as well as the respondent No.1, but in vain.
- 6. The applicants state that as per previous advertisement dated 17.01.2020 (Annexure 'A-6') for the post of Assistant Motor Vehicle Inspector, equivalence of Production Engineering as against the Mechanical Engineering and Automobile Engineering

was accepted. Moreover, All India Council for Technical Education vide notification dated 28.04.2017 (Annexure 'A-7') recognized degree of Production Engineering as equivalence. Moreover, the Principal Bench of MAT at Mumbai in O.A.No. 322 of 2023 by order dated 29.03.2023 has granted interim relief on the basis of equivalence of degree for the post of Food Safety Officer and Assistant Commissioner for Food. Hence, the applicants seek interim relief.

- 7. Learned C.P.O. for the respondents opposed the submissions made on behalf of the applicants and submitted that there is change in Recruitment Rules as regards ARTO and as per present Recruitment Rules dated 16.11.2022, the criteria has been changed and only Mechanical Engineers and Automobile Engineers of four years course are being made eligible. In view of the same, the applicants have no case.
- 8. After having considered the Original Application, Annexures thereof and rival submissions, we find that in the past for the post of Assistant Motor Vehicle Inspector (AMVI) as per

advertisement of 2020 (Annexure 'A-6') equivalence Production Engineering degree to Mechanical. and Automobile Engineering recognized. However, Recruitment Rules of 2022 in respect of ARTO, Group-A, there is specific mention of qualification of Mechanical and Automobile Whether Engineering of four years course. equivalence of Production Engineering Degree can be accepted will have to be seen by taking into consideration any relevant Rules in that regard issued by the Central Government. There is one more aspect of the matter is that the applicants have not challenged the Recruitment Rules for the post of ARTO, which would fall for consideration while considering the Original Application. However, till then if the applicants are deprived of participating into recruitment process, grater hardship is likely to be caused to them, if they ultimately succeed in the Original Application. The issue is debatable one. Hence in our considered opinion, this is a fit case to grant interim relief in terms of prayer clause 'C' in modified for, which is as follows:-

> "C. Pending hearing and final disposal of this Original Application the

respondents may kindly be directed to accept the online applications of the applicants and similarly situated other candidates for the post of ARTO.

But with the rider of keeping the result of the applicants in sealed cover, which would be considered subject to outcome of this Original Application. It is ordered accordingly.

2. The applicant is working as Assistant Professor in Government Engineering College at Aurangabad since the year 2011. It is the grievance of the applicant that though she is praying for her transfer from Aurangabad since the year 2020, her request has not been considered. It is the further contention of the applicant that her daughter is studying in 12th standard and will appear for examination in this year and the son is entering into 12th standard. Both are staying at Pune. Certain other reasons are also mentioned for effecting the transfer. Copies of the representations previously made are placed on record. Statement is made on behalf of the applicant that cognizance of none of the representations has been taken by the respondents and nothing has been communicated to the applicant about the said

representations. In the circumstances, the applicant has filed the present Original Application and has sought directions against the respondents to transfer the applicant at College of Engineering, Pune (COEP) or Government College of Engineering, Avsari, Pune within the stipulated period of time.

- 3. Prayer as has been made by the applicant cannot be granted by this Tribunal. To make the transfers is a prerogative of the employer. Unless any order of transfer is found to have been made against the statutory rules or arbitrarily, the indulgence cannot be caused by the Tribunal. In the present matter it appears to me that except directing the respondents to consider the request of the applicant and to communicate the decision on her representations is the only relief, which may be granted within the jurisdiction of this Tribunal. In the circumstances, it appears to me that the present Original Application can be disposed of at this initial stage itself by giving aforesaid direction.
- 4. The learned C.P.O. is also heard on this point. The learned CPO agrees that in such matters though relief as has been prayed may not be liable to be granted in favour of the applicant, the other request made by the
