It is the contention of the applicant that on the date of submitting the form online though he has duly remitted the examination fees of Rs.294/- through UPI mode (Phonepe) and though the amount was shown to have been debited from the account of the applicant, 7 days' thereafter, it got refunded. However, the applicant was unaware of the said fact and came to know the same after he visited the website on 04-12-2021 and found the remark against his candidature that "fees not paid". It is further submitted that though thereafter the applicant made all efforts of approaching the Maharashtra Public Service Commission (MPSC for short) and for seeking permission to deposit the fees, no favourable response is received. Learned Counsel for the

applicant in the circumstances has approached this Tribunal. He submits that the preliminary examination is scheduled on 26th February, 2022 and in the circumstances, while praying for issuance of notice to the respondents has also prayed for interim relief seeking directions against the MPSC to accept the online application of the present applicant and permit him to appear for the preliminary examination.

- 3. Learned CPO has opposed for granting any such relief and has prayed for some time to file the reply in the present matter.
- 4. After having gone through the documents though there appears that the applicant had deposited the fees online at the time of filing application form at the initial stage and though the amount was deposited but subsequently the same has been refunded and the said fact has not been noticed by the applicant. In the circumstances, we deem it appropriate to direct the MPSC to submit its Say/reply in the matter till 17-02-2022.
- 5. Issue notices to the respondents, returnable on 17-02-2022.

- 6. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- 7. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- 8. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

2. The applicant is presently working on the post of Office Superintendent at Government Medical College at Aurangabad. The applicant has been promoted to the post of Administrative Officer and was directed to resume on her promotional post at Super Speciality Hospital at Latur. It is the case of the applicant that before effecting the promotions, the options were invited and she has not given option for Latur. It is further contention of the applicant that she being on the verge of retirement and only one and half year is left for her to retire, she has given her choice option for Aurangabad. It is further contention of the applicant that the promotional post is also available at Aurangabad, however, without considering the options given by the applicant she has been promoted and posted in the promotional post at Super Speciality Hospital, Latur. It is further contention of the applicant that she has

communicated to the authorities that it may not be possible for her to join at Latur and in the circumstances if any candidate junior to her is promoted to the said post she will not have any objection. According to the learned Counsel, the communication impliedly means that the applicant has denied the promotion. Learned Counsel further submitted that an employee possesses right to deny the promotion and accordingly the said right is exercised by the applicant. In the circumstances, the present O.A. is filed seeking quashment of the order dated 19-01-2022 and interim relief is also sought for not giving effect to the said order and allow the applicant to continue to discharge her duties on the existing post at Aurangabad.

- 3. The learned Chief Presenting Officer has opposed for granting any such interim relief and has sought some time for filing the detailed reply to the Original Application so submitted by the applicant. It is the contention of the learned CPO that the applicant has been already relieved and in such circumstances, no interim relief as has been prayed is liable to be granted.
- 4. We have gone through the documents and the contents in the Original Application. It has also been pointed out by the learned Counsel for the applicant that in the similar set of facts this Tribunal in O.A.No.64/2022

has granted interim relief in the favour of the applicant therein. On the principle of parity, same relief is being sought in the present matter. In view of the submissions made and more particularly, *prima facie*, when it is revealing that the applicant has impliedly denied the promotion, we are inclined to pass the following order:

- i) Issue notice to the respondents, returnable on 04-03-2022.
- ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- iii) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- iv) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

- v) The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

In the meanwhile the order dated 19-01-2022 issued by the respondent no.2, which is impugned in the present application, shall stand stayed and the respondent no.3 shall permit the applicant to discharge her duties on the present post i.e. Office Superintendent at Government Medical College at Aurangabad.

- 2. M.A. No. 145/2021 has been filed by the applicant for condonation of delay occurred for filing the O.A.
- 3. It is the contention of the learned Counsel for the applicant that the applicant was bona-fide believing that his grievance will be redressed by the respondents and therefore he was making representations with the authorities, however, his grievance has not been redressed by the authorities. It is further contention of the learned Counsel for the applicant that in the meanwhile because of Covid-19 pandemic situation the applicant could not take further steps for filing the O.A. He further submitted that the applicant is having very good case on merit and if the delay occurred in

filing O.A. is not condoned, the applicant may lose the chance to ventilate his grievance.

- 4. The learned P.O. prays for passing appropriate order.
- 5. After having considered the M.A. and the reasons assigned for condonation of delay, it appears that the reason for occurrence of the delay for filing the O.A. is the period of COVID-19 Pandemic, wherein the people were unable to access the Court. Even otherwise it appears to us that the dispute raised by the applicant in the O.A. deserves to be considered on merit. Hence, we are inclined to condone the delay occurred for filing the O.A. Hence, the following order:-

- (ii) The delay occurred for filing the O.A. is condoned.
- (iii) Registry to register the accompanying O.A. according to law.
