3. Learned P.O. has sought time for filing affidavit in reply on behalf of respondent Nos. 1 to 4. Time granted.

ORIGINAL APPLICATION NO. 996/2022 (Smt. Jyoti Popat Shete Vs. State of Maharashtra & Ors.)

Heard Shri S.D. Joshi, learned counsel for the applicant and Smt. Deepali S. Deshpande, learned Presenting Officer for the respondent authorities.

2. The applicant, who is a lady Police Constable, is seeking directions for her inter-district transfer. After completing her training the applicant was firstly posted at Dadar, where she worked for full term of 3 years. In the meanwhile the applicant got married and also gave birth to a baby girl prematurely. At the relevant time the husband of the applicant, who was also in Police Department, was posted at Manmad, the applicant had opted for her inter-district transfer at Manmad. However, when her request was under consideration in the meanwhile period the husband of the applicant came to be transferred at Wardha on his request. In the circumstances, the applicant was constrained to make another application modifying her request for her interdistrict transfer in Wardha District. Since her request was not favourably considered, the applicant has approached this Tribunal seeking direction to the

respondents for considering her request for inter-district transfer favourably in Wardha District.

- 3. Respondent nos. 2 & 3 have filed their affidavit in reply on 10.1.2023. Today when the present matter is heard the learned counsel for the applicant invited my attention to last few lines of para 10 of the said affidavit in reply. The learned counsel submitted that in view of the fair approach as has been taken by the respondents, the present Original Application can be disposed of by giving directions to the respondents to consider the request of the applicant as favourable indications are given by the respondents in their affidavit in reply.
- 4. The learned Presenting Officer submitted that the Department is bound by the rules and regulations framed. The learned Presenting Officer submitted that as per the prevailing practice and rules in a year not more than 31 applications can be considered for inter-district transfers. The learned Presenting Officer submitted that since at the relevant period said number of applications were already considered, the request of the present applicant could not be considered. The learned Presenting Officer submitted that as averred in para 10 of the affidavit in reply the respondents will consider the request of the applicant for this year. The learned

Presenting Officer submitted that since the affidavit in reply has been filed in the month of January, 2023, it has been mentioned that the request of the applicant will be considered in the next year. The present is the period wherein the annual general transfers are proposed and allied requests are considered.

5. After having heard the learned counsel for the applicant and after having perused the pleadings in the Original Application, it appears to me that without going into the merits of the Original Application it can be disposed of in view of the stand taken by the respondents in para 10 of the affidavit in reply, which I have already referred herein above. Hence, I pass the following order:-

ORDER

- (i) The respondent authorities as per the averments in para 10 of their affidavit in reply shall consider the case of the applicant for her inter-district transfer in the quote of this year i.e. 2023 on its own merit and in accordance with the rules in that regard.
- (ii) With the direction as above, the Original Application stands disposed of, however, without any order as to costs.

ORIGINAL APPLICATION NO. 280/2023 (Smt. Varsha Shankar Shikhare Vs. State of Maharashtra & Ors.)

Heard Ms. Preeti Wankhade, learned counsel for the applicant and Smt. Deepali S. Deshpande, learned Presenting Officer for the respondent authorities.

- 2. The applicant has preferred the present Original Application seeking quashment of the order dated 31.3.2023 whereby she has been transferred from Nanded to Jalna. The applicant is a lady Constable working in Excise Department. She came to be appointed on her existing post on 9.10.2020 on compassionate ground in place of her husband, who died while in service in the year 2016. From the date of her appointment the applicant is posted at Dharmabad and is discharging her duties. When the applicant was on outdoor training in the meanwhile the impugned order has been issued.
- 3. The learned counsel for the applicant submitted that the applicant has been shifted from Dharmabad to Jalna being a surplus candidate. The learned counsel

pointed out that according to the Government Resolution dated 10.9.2001 issued by the Finance Department of the State a procedure has been laid down in the event the candidates are declared surplus for accommodation at the same station or at any other The learned counsel submitted that in the present matter, however, the procedure as has been laid down in the said G.R. dated 10.9.2001 and more particularly clauses 6, 7, 10 & 11 of its Appendix-3 have not been followed. In the circumstances, the learned counsel has also prayed for interim relief while issuing respondents the notices to the to stay implementation of the impugned order dated 31.3.2023. The learned counsel submitted that father-in-law of the applicant is a cancer patient and he requires constant care. Moreover, son of the applicant will enter in 10th standard from the next academic year. The learned counsel submits that the applicant has, thus, made out a prima-facie case for interim relief.

4. The learned Presenting Officer sought time to file the affidavit in reply in the matter. The learned Presenting Officer opposed for granting any ex-parte interim relief stating that there are no instructions from the respondents and even the request for interim relief cannot be considered in absence of any instructions from the respondents.

5. I have considered the submissions advanced by the learned counsel appearing for the applicant, as well as, the learned Presenting Officer. I have also perused the documents filed on record. The G.R. dated 10.9.2011 is crucial having regard to the objections raised in the present matter. As is revealing from the pleadings and the arguments advanced by the learned counsel for the applicant, the applicant was not even given any idea that she is being declared surplus in the Nanded Region and is likely to be transferred in some other District. applicant also did not get any opportunity for making a representation to the respondent authorities. It appears to me that having regard to the G.R. dated 10.9.2001 and more particularly Appendix -3 of the said G.R., the applicant must have been given an opportunity of On perusal of the aforesaid G.R. and the hearing. scheme as envisaged in Appendix-3 apparently it appears that the prescribed procedure has not been followed while passing the impugned order.

6. There appears no reason for disbelieving the facts stated by the applicant on oath. If it is subsequently revealed that the facts were not correctly stated, the applicant would suffer its consequences. Having considered the facts as are revealing from the pleadings, it appears to me that, there is no propriety in issuing notice to the respondents and keeping the matter pending and to grant the interim relief in the meanwhile period. On the contrary, it would be in the interest of both the applicant, as well as, the respondents if the application is disposed of at this stage itself by giving liberty to the applicant to make a detailed representation and the direction to the respondents to consider the said representation on its own merit and in accordance with the relevant provisions and the G.R. dated 10.9.2001. As such, the following order is passed:-

ORDER

- (i) The applicant shall make a detailed representation with the appropriate authority ventilating her grievance within one week from the date of this order.
- (ii) If such a representation is made within the given period, the respondents shall decide the same on its own merit and in accordance with the relevant legal provisions, as well as, G.R. dated 10.9.2001 within next 2 weeks and till then shall not act upon the order dated 31.3.2023.

- (iii) Needless to state that even then if any grievance remains, it would be open for the applicant to approach this Tribunal.
- (iv) The Original application stands disposed of in the aforesaid terms without any order as to costs.
