The Original Application is filed for seeking relief in terms of prayer clause 12(A) as follows:-

- "12(A) This Original Application may kindly be allowed thereby directing Resp.No.1 to prepare & publish Annual Gradation of the cadre of Research Officers/Statistical Officers from the Group-B Gazetted cadre 01/01/2002 onwards within stipulated period of time as may be deemed fit by this Hon'ble Tribunal."
- 2. During pendency of O.A., the Misc. Application No.212/2021 has been filed for seeking interim relief in terms of prayer clause 15 (A), (B), (C) and (D).
 - "15(A) This Misc. Application may kindly be allowed.
 - (B) The Resp.No.1 may kindly be restrained from effecting any promotions to the cadre of Deputy Directors on the basis of the provisional Seniority List dated 23/07/2021 (Annex.A-3) of the cadre of Research Officers/Statistical Officers.
 - (C) The Resp.No.1 may kindly be directed to finalise the provisional Seniority list dated 23/07/2021 (Annex.A-3) of the cadre of Research Officers/Statistical Officers only & only after considering & deciding all the objections raised thereto.

- (D) The Resp.No.1 may kindly be further directed to effect promotions to the cadre of Deputy Directors only on the basis of the final Seniority List of the cadre of Research Officers/Statistical officers that may be prepared after considering & deciding the objections raised to the provisional Seniority List dated 23/07/2021 and only after a period of 30 days from the date of publication of said final Seniority List.
- 3. During pendency of the said Misc. Application, by order dated 9.8.2021 ad-interim relief in terms of prayer clause 15 (B) of Misc. Application No.212/2021 was granted. Thereafter, Misc. Application No.285/2021 was filed by the applicant by seeking amendment in M.A.No.212/2021. By order dated 27.09.2021, the amendment sought for was allowed and order of interim relief dated 9.8.2021 was vacated. Thereafter, the applicant has carried out amendment in M.A.No.212/2021.
- 4. We have heard Shri Avinash S. Deshmukh, learned Advocate for the applicant, Shri M.S. Mahajan, learned Chief Presenting Officer for the respondent Nos.1 to 3 and Shri S.G. Kulkarni, learned Advocate holding for Shri Ajay S. Deshpande, learned Advocate for the respondent Nos.5 & 6. Shri M.S. Sonwane, learned Advocate for the respondent No.4 is **absent**.

- 5. Learned C.P.O. for the respondent Nos.1 to 3 and learned Advocate for the respondent Nos.5 & 6 submit that they have received the amended copy of Misc. Application No.212/2021 today itself and they seek short time for filing affidavit-in-reply to the amended M.A..
- 6. Learned Advocate for the applicant submitted that he is seeking ad-interim-relief in terms of amended prayer clause "15-E-1" in respect of interim relief of prayer clause "15-A-1". Prayer clause 15-A-1 is as follows:-
 - "15-A-1. The Resp.No.1 may kindly be restrained from effecting any promotions to the cadre of Deputy Directors unless & until the *final seniority list* of the cadre of Research Officers/Statistical Officers for preceding year is prepared published in terms of the provisions of paragraph no.5.2.1 of G.R. dated 01/08/2019 r/w provisions of Rule 7 of the MCS (Regulation of Seniority)Rules, 1982.
- 7. Learned Advocate for the applicant produced on record the copy of letter dated 27.09.2021 issued by the Deputy Director (Administration), Directorate of Economics and Statistics, Mumbai. In view of letter dated 27.09.2021, the respondent no.1 is seeking choices from the officers who are in the zone of consideration for the post of Deputy Director.

- 8. Learned Advocate for the applicant submits that the Government is going to consider 13 officers and he produces the said list. However, the said list does not bear stamp or signature of anybody.
- 9. Learned Advocate for the applicant invited our attention to G.R. dated 1.8.2019 of G.A.D. which provides the guidelines for effecting promotions. Learned Advocate for the applicant submits that the seniority list of the cadre of Research Officers/Statistical Officers, which is feeding cadre of the Deputy Director is finalized only as on 01.01.2013.
- 10. Learned C.P.O. submits that it is finalized as on 01.01.2014.
- 11. Learned Advocate for the applicant submits that unless the seniority list is finalized as on 1.1.2019, the Government at this juncture cannot undertake to start the process of promotion to promote the officer for the post of Deputy Director. It is his contention that immediately after allowing the amendment by this Tribunal by order dated 27.09.2021, the Government has acted surprisingly swiftly by issuing abovesaid letter dated 27.09.2021. He submits that it is done with malafide intention to favour some of the officers and defeating the rights of the applicant. In view of same, he is seeking ad-interim relief.

- 12. Learned C.P.O. on the other hand submits that the Respondents have received amended copy of the application today itself. He also invited our attention to interim modified order dated 21.01.2020 passed in O.A.No.694/2018, whereby the statement of learned C.P.O. was recorded to the effect that the Respondents are not going to promote anybody, who are junior to the present Applicant. According to him, it is suffice to protect the interest of the applicant.
- 13. Upon perusal of prayer in the Original Application and subsequent pleadings raised by the applicant in the Misc. Application No.212/2021, it is seen that detailed contentions have been raised by the applicant for seeking interim relief during pendency of the Original Application in respect of process of promotion.
- 14. The apprehension of the applicant is that the respondent Government without following due procedure laid down in G.R. dated 01.08.2019 are trying to give promotion to the officers. According to him, unless final seniority list is finalized as on 01.01.2019, no such endeavor can be done by the Government to give promotion in pick and chose manner or for that matter in piecemeal.
- 15. The contentions of the applicant definitely are of serious nature and are having longstanding effect.

However, in order to have proper adjudication, in our opinion, opportunity should be given to the respondents to file reply to the amended pleadings at the earliest.

16. In the circumstances, *prima facie*, it is not a fit case to grant ad-interim relief, when statement of learned C.P.O. is already recorded as discussed hereinabove. Thereby the interest of the applicant seems to have been protected substantially. We, therefore, grant short time to the respondents to file affidavit-in-reply.
