He also submits that father of the applicant expired in the year 2011 and due to all these domestic difficulties he was unable to approach the competent forum for redressal of his grievance within time.

4. Learned P.O. objected the submissions. She submits that vague pleadings are made by the applicant for challenging the impugned order of termination. There are no justifiable reasons.

5. Upon hearing both the sides, in our view, the applicant has not made out the case for condonation of 9 years & 10 months delay caused in filing the accompanying O.A. The delay is not properly explained. In the circumstances, the present misc. application is dismissed. In view of dismissal of misc. application, the registration of original application is hereby refused. There shall be no order as to costs.
