Learned counsel for the applicant submits that in terms of the Order No. 8 of the Maharashtra Village Police Patil's (Recruitment, Pay, Allowance and Other Conditions of Service) Order, 1968, engagement in business or trade of the Police Patil concerned is impermeable. However, the Police Patil may cultivate land or engage in local business or trade in the village, in such manner as is not detrimental to the performance of his duties as Police Patil, but he shall not undertake any full-time occupation elsewhere.

5. Learned counsel for the applicant submits that the applicant has brought to the notice of respondent No.1 by way of filing his explanation during the said enquiry that the applicant was merely working as Recovery Agent of Adani Capital which is private company and it is not full time job. However, considering the nature of his job which is mere recovery of loan amount given by the said company to the various persons, the said job is not detrimental for performing his duties as a Police Patil.

6. Learned Presenting Officer for the respondents submits that after full-fledged enquiry in this regard the respondent No.1 has come to the conclusion that the applicant is performing the duties which is detrimental to his duties as a Police Patil. 7. It appears that the Police Patil is not getting any salary and he only works on meager amount of remuneration. In view of the same, his occupation as cultivator of land or engaged in local business or trade in the village which is not detrimental to the performance of his duties as a Police Patil and it is not full time occupation elsewhere, is permissible.

8. In the instant case the applicant is performing part time job as recovery agent at private company which prima-facie appears to be not detrimental to the performance of his duties as a Police Patil. In view of same, I am inclined to pass interim relief in

favour of the applicant in terms of prayer clause 'B' till filing of reply at present which reads as :-

In fact, the applicant is already working on the non-executive post in Dial 112, Manvat Police Station and in view of said direction, there was no need to transfer him to another district. Learned counsel on instructions from the applicant submits that though the applicant is relieved, he has not joined on the post of transfer and no other officer joined on his place in Parbhani District.

4. In view of the above submissions and on careful perusal of the directions given by the Election Commission of India Annexure A-2 and Annexure A-4 respectively, I find much substance in the submissions made on behalf of the applicant.

3. The applicants claimed to be belonging to Scheduled Tribe category. They had applied for the post of Planning Assistant, Group-B (Non-Gazetted) in pursuance of the advertisement published by respondent no. 02 on 28.3.2023. Total 115 posts were advertised, out of which 26 posts are reserved for S.T. candidates. From amongst 26 posts reserved for S.T., 08 are reserved for S.T. Women, 01 for S.T. sports person and 17 posts were reserved for S.T. General.

4. It is the case of the applicants that their names have been recommended from the category they had applied for, however, appointment orders are not issued as the applicants are yet to submit tribe validity certificate on record. Learned counsel for the applicants submitted that at the time document verification, the applicants have placed on record the tribe certificates, as well as, the copy of the letter with acknowledgement, whereby request is made to the Tribe Verification Committee to validate the tribe certificates issued in favour of them. In the broacher along with the advertisement published, a provision is there allowing the selected candidates from the reserved class, period of 06 months for submitting the Caste/Tribe Validity Certificate after their appointment and subject to that a temporary appointment is to be issued to the candidate concerned.

5. The learned counsel submits that in view of such provision in the broacher the respondents were under an obligation to issue appointment in favour of the applicants, subject to production of

caste/tribe validity certificate within the period of 06 months. Learned counsel submitted that the process of issuing orders of appointment is in progress and wait list candidates are likely to be given the appointments in place of the applicants. In the circumstances, request has been made for directions against the respondents not to fill in the posts reserved for S.T. (General) candidates more particularly in place of the applicants, who are at sr. nos. 14 & 17 in the S.T. (General) category.

6. Learned Chief Presenting Officer seeks time to take instructions from the respondents and to file the affidavit in reply.

7. Advertisement on record shows that out of 115 posts advertised, 26 are reserved for the candidate belonging to ST. From out of said 26 seats, 17 seats are reserved for ST (General). The list of selected/recommended candidates contains the names of both these applicants from ST (General) category, 01 is shown as ST (General) 14 and other as ST (General) 17. The broacher with the advertisement contains the provision that the

candidates, who are selected from reserved category can be permitted to submit the Caste/Tribe Validity Certificate within a period of 06 months from the date of their appointments and subject to taking such an undertaking by the candidates concerned a temporary appointments can be issued in favour of such candidates. It is the contention of the applicants that they have not been given the appointments only on the ground that at the time of document verification they did not submit the caste/ tribe validity certificate. The respondents have yet to file the affidavit in reply. At this juncture there is no reason to disbelieve the statements made by the applicants on affidavit.

8. From the list of recommended candidates there is reason to believe that both the candidates are selected and recommended for their appointments against the seats reserved for ST (General). The applicants apprehend that the respondents may issue order of appointments to the next general candidates in order of merit, if the said candidates submit the caste/tribe validity certificates. Applicants have placed on record the document

showing that they have already applied for their tribe certificate verification to the Tribe Certificate Validation Committee. In the circumstances, as provided in the broacher along with advertisement, prima facie, there is reason to believe that the respondents could have issued provisional / temporary appointment orders in favour of the applicants by obtaining undertaking from them to submit the tribe validity certificate within the period of 06 months. For the reasons stated above, we are inclined to pass the following order: -

# <u>O R D E R</u>

(i) Issue notice to the respondents, returnable on 20.2.2024. If there is no legal impediment except that the applicants have not submitted tribe validity certificates, the respondents shall keep 02 seats reserved for ST (General) unfilled till filing of their affidavit in reply.

(ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

(iii) Applicants are authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to
