JUDGMENT

1. Heard Shri M.B. Kolpe, learned Advocate holding for Shri V.B. Deshmukh, learned Advocate for the applicant and Shri D.R. Patil, learned Presenting Officer for the respondents.

2. Present Original Application has been filed by the applicant for the following reliefs :-

“(C) To quash and set aside the termination order dated 12.9.2014 issued by Dean of Shri Bhausahab Hire Medical College, Dhule.

(D) By issuing appropriate and necessary orders, the respondents may kindly be directed to regularize or absorb the applicant in service.

(E) By issuing appropriate and necessary orders or directions the respondents may kindly be directed to consider the claim of applicant to regularization or absorption service of the applicant in Public Health Department.”

3. Submissions from both the sides and affidavit in reply filed by the res. nos. 1 to 3 would show that while the present applicant was appointed on ad-hoc basis as an Assistant Professor, though not qualified, now the qualified employee is

appointed on regular basis. The present applicant was merely an ad-hoc appointee.

4. In the above circumstances, the present Original Application is dismissed without any order as to costs.
