The present O.A. is filed challenging the impugned order dated 01.07.2022 (Annexure A-1) issued by the respondent No. 4 i.e. the Chief Executive Officer, Zilla Parishad (Health Division), Latur, Dist. - 2. By this Misc. Application, the applicant is seeking condonation of delay of about 794 days caused in filing the accompanying Original Application under Section 19 of the Administrative Tribunals Act, 1985 challenging the impugned recovery order dated 20.10.2015 (Annexure A-1 in O.A.) issued by the respondent No. 2 i.e. the Superintendent of Police, Nanded towards fine for unauthorized use of the Government servant even after transfer of the applicant from Nanded to Himayatnagar vide transfer order dated 10.07.2011 (Annexure A-5 in O.A.).
- 3. Admittedly at the time of issuance of the transfer order dated 1.07.2011 (Annexure A-5 in O.A.), the applicant along with his family was living in Government quarter allotted to him at Nanded. After his transfer from Nanded to Himayatnagar vide

transfer order dated 10.07.2011 (Annexure A-5 in O.A.), the applicant did not vacate the said quarters. He vacated the said government quarters only in February, 2014.

- 4. The impugned order dated 20.10.2015 (Annexure A-1 in O.A.) issued by the respondent No. 2 after receipt of account verification report of the Accountant General-II, Nagpur for the period of 01.03.2011 to 31.03.2013, thereby recovery of an amount of Rs. 1,70,348/- towards fine for unauthorizedly overstaying in the Government quarters is ordered.
- 5. It is the contention of the applicant that the said impugned recovery order is directly in contravention of the provisions of the G.R. dated 06.08.2002 (Annexure A-11 in O.A.), whereby it is provided that if the Government servant is transferred to Naxalite affected area, then he is allowed to retain the Government quarters allotted to him immediately before such transfer for three years or till the period of tenure in Naxalite affected area, whichever is earlier. The applicant said to have vacated the Government quarters within the said stipulated period of three

years. In view of the same, it is the contention of the applicant that he has good case on merits. After receipt of the said impugned recovery order dated 20.10.2015, the applicant said to have made various representations seeking exemption from the said recovery. He made such representations from December, 2015 to February 2019 as reflected in Annexure A-1 collectively in M.A. It is further contention of the applicant that due to lack of practical knowledge of legal provisions, he could not file the Original Application in time. Hence, the present Misc. Application.

- 6. The affidavit in reply is not filed on behalf of respondents, in spite of grant of opportunities. Hence, hearing of the present M.A. proceeded without affidavit in reply.
- 7. After having considered the contentions raised in the O.A. and M.A. prima-facie, the applicant has good case on merits. Facts also reveal that some of the amount is recovered from the salary of the applicant. However, now further recovery is not going on for whatever reasons.

- 8. Considering the dates involved in the matter, it is evident that there is delay of about 794 days as pleaded by the applicant.
- 9. From the facts and circumstances, it cannot be said that the delay was caused by the applicant deliberately or intentionally, thereby the applicant had nothing to gain. It is a settled principle of law that the expression "sufficient cause" is to be construed liberally. In view of the facts and circumstances, refusing to condone the delay is likely to defeat the cause of justice at the threshold. In view of the same, in my considered opinion, this is a fit case to condone the delay by imposing the moderate costs of Rs. 1000/- on the applicant. Hence, I proceed to pass following order:-

ORDER

The Misc. Application No. 24/2020 is allowed in following terms:-

(i) The delay of 794 days caused for filing the accompanying O.A. under Section 19 of the Administrative Tribunals Act, 1985 is hereby condoned subject to payment of
