2. The present M.A. is filed seeking the extension of time to comply the order passed by this Tribunal on 5.4.2022 in O.A. No. 260/2021. Para 5 of the said order is material in the present context, which is reproduced herein below :-

“5. Pandemic situation is now well within control and the Government has lifted almost all the restrictions, which were imposed during the said period. In the circumstances, it does not appear to us that there may be any difficulty for respondent authorities to initiate the process for promotion on the post of Agriculture Supervisor in Group-C insofar as the quota meant for the employees working on the post of Agriculture Assistant is concerned. We therefore direct the respondents to commence the process of effecting the promotions for the departmental persons to the post of Agriculture Supervisor in Group-C and complete the entire process within the period of 4 months from the date of this order.”

3. Having regard to the fact that for conducting the examination reasonable time of 4 months was provided to the respondents, in the present application while seeking extension of said time the respondent authorities were expected to bring to our notice what effective steps are taken towards compliance by the respondent authorities. Except the copies of internal correspondence between authorities nothing has been placed on record in that regard by the respondent authorities. In the order passed in O.A. it has been clarified that since 2018 the promotions are not effected, which are meant for departmental persons. However, it appears to us that unless limited departmental examination is held it may not possible for the respondents to effect the promotions. Time sought therefor as 8 months is apparently unreasonable. The said process can be completed within next 2 months, if the respondents are serious in complying with the order of the Tribunal and serious about the persons waiting for promotions since last 5 years. Therefore, we extend the time by 2 months for complying the order of the Tribunal.

3. With the above directions to the respondent authorities to comply the said order by extended time, the present M.A. stands disposed of without any order as to costs.
