- 2. The present application is filed for condonation of delay which has occasioned in filing accompanying O.A. In the O.A. the applicant is seeking quashment of the chargesheet dated 5.2.2010 issued by the respondents. Considering the prayer clause, outwardly it may appear that the delay occasioned is about the period of 9 years. The learned counsel for the applicant however brought to our notice that since the applicant was ready to participate and face the enquiry, there was no reason to approach the Tribunal. But when nothing effective happened during the period 2010 to 2019, ultimately the applicant has filed the present O.A. for quashment of the enquiry with the present application seeking condonation of delay. The delay occasioned is unintentional and for bona-fide reason, the learned counsel added.
- 3. The learned Presenting Officer opposed for condoning the delay stating that the reasons assigned are not cogent and sufficient. He therefore prayed for dismissal of the present application.

- 4. After having gone through the pleadings in the present M.A., as well as, in the O.A., it appears to us that the delay in the present matter has to be condoned for the reasons as are stated in the said application. As has been stated by the learned counsel for the applicant up to the year 2016 the applicant was participating in the enquiry proceeding and has also submitted his say to the charges leveled against him. According to the applicant, the respondents are harassing him by keeping the enquiry proceeding pending for years together.
- 5. The learned counsel for the applicant has brought to our notice that the departmental enquiry has not proceeded an inch further. In the meantime the applicant has got retired on attaining the age of superannuation and his pensionary benefits are not fully paid
- 6. In the above circumstances, we are inclined to condone the delay so that the applicant may get an opportunity to prosecute the O.A. on merit. Hence, the following order:-

ORDER

- (i) The M.A. stands allowed with no order as to costs.
- (ii) The delay occurred for filing the O.A. is condoned.
- (iii) Registry to register the accompanying O.A. according to law.

- 2. The present applicant has been held not eligible for the admission to the P.G. course through in-service quota on the ground that the applicant appeared for NEET PG 2022 examination held on 21.5.2022 without obtaining the NOC from the competent authority before the date of the said examination and the NOC was obtained on 3.6.2022 i.e. after the date of the said examination.
- 3. The learned counsel for the applicant invited our attention to the letter dated 11.3.2022 (Annex. A-1 page 20 of paper book) written by the Civil Surgeon, Civil Hospital, Parbhani to the Deputy Director of Health Services, Aurangabad Region. The said communication reveals that the applicant had preferred the application on 10.1.2022 and the said application was forwarded by the Civil Surgeon, Civil Hospital, Parbhani to the Deputy Director of Health Services, Aurangabad Region on 4.3.2022. The Learned counsel for the applicant submitted that the applicant had applied well within the date before the said examination. He further submitted that if the delay had

occurred on part of the respondents in according such permission the applicant cannot be blamed and cannot be deprived from the right which has accrued in her favour.

- 4. The learned Chief Presenting Officer opposed for granting interim relief stating that time may be provided to take instructions as to why the delay had occurred in deciding the proposal of granting NOC to the applicant.
- 5. The learned counsel for the applicant submitted that the applicant had applied within time limit prescribed for grant of NOC, therefore, the applicant cannot be held responsible for delay caused by respondent authorities in granting NOC. The learned counsel for the applicant further pointed out that the process of admission has already began and if the candidature of the applicant is not considered, she may lose the chance of admission.
- 6. We have carefully considered the submissions advanced on behalf of the parties. We have perused the documents filed on record. The permission has been refused to the applicant on the sole ground that she did not seeks permission within prescribed time limit before appearing the NEET-PG-2022 examination. By placing on record the document at Annex. A-1 page 20 of paper book, which is referred hereinabove, the applicant has made out a prima-facie case evidencing that she had duly applied for permission to appear for NEET-PG-2022 examination in advance by filing application dated 10.1.2022. At present there is nothing contrary on record. The applicant has asserted that the delay in granting the permission has not at her instance. In the circumstances, it appears to us that the applicant has certainly made out a prima-facie case for

grant of ad-interim relief in her favour. Hence the following order:-

- 3. The learned Presenting Officer opposed for condoning the delay stating that the reasons assigned are not cogent and sufficient. He therefore prayed for dismissal of the present application.
- 4. From the documents filed on record and after hearing the submissions of both the sides it reveals that the applicant was prosecuting the Writ Petition. However when it was brought to the notice of the Hon'ble High Court that the applicant has an alternate remedy before the Tribunal, the applicant has withdrawn the said Writ Petition and Hon'ble High Court has granted liberty to file O.A. before this Tribunal.
- 5. The learned counsel for the applicant has brought to our notice that the departmental enquiry has not proceeded an inch further. In the meantime the applicant has got retired on attaining the age of superannuation.
- 6. It is true that despite having alternate efficacious remedy to raise the grievance before this Tribunal, the applicant filed the Writ Petition before the Hon'ble High Court. However, it cannot be said that there was any malafide in filing such petition or that it was deliberate attempt on part of the applicant to file the Writ Petition before the Hon'ble High Court. As has been submitted by the learned counsel, the applicant was bona-fide prosecuting the remedy of Writ Petition and the moment it was realized that there is alternate efficacious remedy, the applicant sought leave from the Hon'ble High Court to withdraw the said petition with liberty to file the same before this Tribunal. As such, we are inclined to allow the present application. Hence the following order:-

- 4. Learned P.O. opposed for condoning the delay stating that reasons as are assigned are neither cogent nor sufficient. Therefore, he has prayed for rejection of the M.A.
- 5. After going through the pleadings and arguments advanced by both the sides, it appears to us that

matter will have to be decided on merit and delay has to be condoned. Since the Government itself has stayed the further departmental enquiry proceedings in 2012 and the same is not proceeded further till date, as has been submitted by the learned Counsel, the matter needs to be inquired into thoroughly. Hence, we pass following order:
